FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE World Europe ex-UK TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

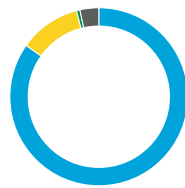

FUND MANAGER COMMENTARY

European equities continued their recent upward trend in December. Although somewhat less dramatic than the previous month's movements, markets were in a favourable mood ahead of the festive holiday period. Despite a strong start to the month we saw some retracement of value and momentum styles as growth and quality cyclical found favour once again. On the news front, the market reacted positively to the UK and EU finally agreeing a trade deal, over four and a half years after the Brexit referendum result. Elsewhere, the roll out of the Pfizer vaccine commenced in the period, following EU approval for use. The next few months will be critical, with coronavirus cases currently rising sharply, bringing expectations of further lockdown measures. For sector performance, we saw Technology, Oil & Gas and Consumer Goods enjoyed a strong month for price action.

The L&G European Equity Income fund delivered returns that outperformed its benchmark. Stock selection contributed entirely to the outperformance, led by our names in Utilities and Basic Materials. Sector allocation made a negative contribution, driven by our underweight position in Consumer Goods, and our overweight position in Telecommunications. At the stock level, the top performers included Siemens Energy, ArcelorMittal and EDP. Notable underperformers were Ericsson and Saint Gobain.

There were no notable portfolio changes during the period.

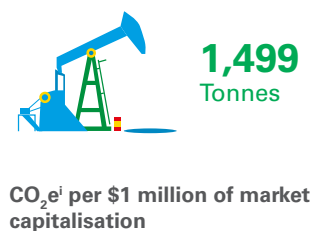


ANDREW KOCH

ENVIRONMENTAL PERFORMANCE

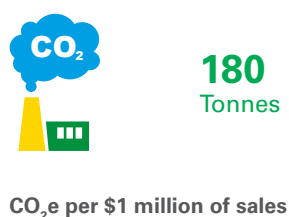
Carbon dioxide (CO₂) is the most significant contributor to greenhouse gas emissions which are driving climate change.



CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.



CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its salesⁱⁱ.
