FUND AIM

The objective of this fund is to provide an income in excess of the yield represented by the performance of the FTSE All-Share Index, and long-term growth. The fund will typically invest between 80% and 100% in UK company shares, or in shares of overseas companies which have a significant part of their activities in the UK or whose shares are traded on UK stock markets.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 5 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

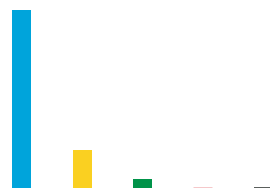

FUND MANAGER COMMENTARY

Despite seeing a return of global growth worries and a sharp move on bond markets, equities have broadly brushed aside these concerns. UK equities have been impressively resilient in Q1, given volatility in currency moves and a lack of enthusiasm from global asset allocators.

In the UK, while business sentiment and activity indicators are subdued, the labour market and consumer confidence readings appear as bright spots. PMI data for the region was better, but impacted by a stockpiling effect ahead of the Brexit deal.

Arguably, any investor conservatism is reflected in the mixed signals we have seen on size, style and sector returns. Large-caps were the size winners, while value underperformed. The strength of the FTSE 100 was spurred on by strong gains in consumer staples, resources and telecoms. Notably, UK miners made both short and long term relative highs. On the flipside, financials, utilities and leisure stocks were out of favour.

On performance, the L&G UK Equity Income fund returned 2.5%, which represented a second consecutive month of performance that was broadly in line with the index return. Sector allocation was a headwind, predominantly driven by our underweight positioning in the large-cap consumer staples sector. Elsewhere, our overweight in financials also detracted value, given the negative returns from banks. On a more positive note, stock selection added value following good returns in our industrials and resources.



STEPHEN MESSAGE
