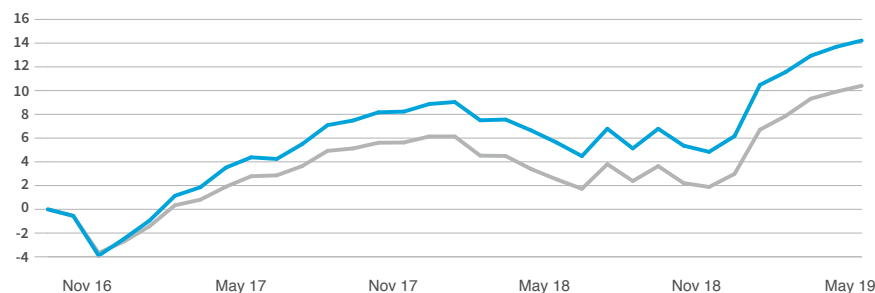

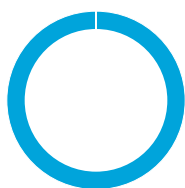

KEY RISKS
