FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 5% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

FUND SNAPSHOT

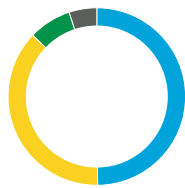
- **What does it invest in?** Invests at least 80% in shares of UK companies which are considered to be undervalued by the market, where the Manager believes there to be a catalyst (a feature or market event) which should increase the value of the company.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.

FUND MANAGER COMMENTARY

The UK equity market performance was very strong in November, pushed upward by positive vaccine trial news fuelling a risk-on environment. Early results showed numerous vaccines in development to be over 90% effective and the UK government started to prepare for a vaccination program to begin in December. The combination of hopeful vaccine news and receding US political event risk drove strong equity performance in what proved to be one of the best months for global equity returns since the 1980s. In addition, the vaccine news brought a record style rotation, with Value and Recovery names outperforming Growth and Quality. Other news included the Bank of England announcing a further £150 billion stimulus and keeping interest rates on hold at 0.1% in order to boost spending in the UK economy. In terms of economic data releases, UK Gross Domestic Product expanded by just 1.1% in September, weaker than economists had expected.

The L&G UK Special Situations Trust outperformed against its benchmark in November. Stock selection contributed entirely to the outperformance, with strong performance in Consumer Services and Consumer Goods. Sector allocation was slightly negative, led by weakness from the overweight positioning in Technology and Industrials. At the individual stock level, the top performers included SSP Group, Taylor Wimpey and Gym Group. Underperforming names included Blue Prism, RWS Holdings and Biffa.

In terms of new activity, we exited our position in uranium investment company Yellow Cake, and entered a new position in in patent translation company RWS Holdings.

CARBON RESERVES

CARBON EMISSIONS
