



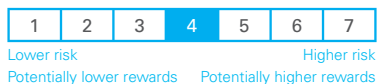
L&G Absolute Return Bond Plus Fund

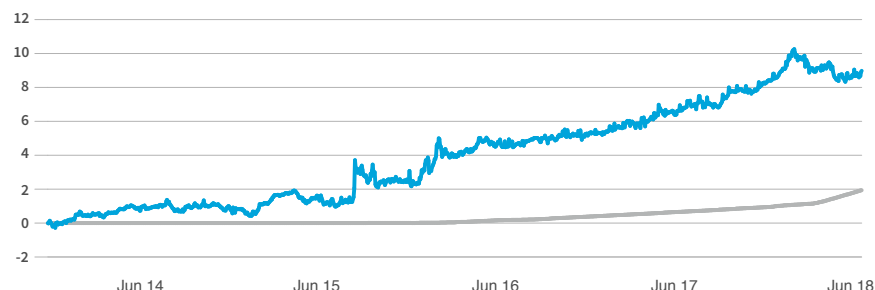

FUND MANAGER COMMENTARY

June was another weak month for risk markets, particularly across credit. There were pockets of resilience, notably US high yield credit and US equity markets, but other areas suffered large losses. While the Italian political volatility of May calmed, it was replaced with a focus on trade tariffs and associated political tension.

The fund delivered positive returns in June. Although our holdings in investment grade bonds generated negative returns, our short CDS position in investment grade credit helped to protect the portfolio. We also entered short CDS positions in a basket of commodity and automobile companies. The market exposure of those positions is hedged by long positions in CDS indices. These pair trades performed well and we continue to hold them. In currency markets, we added to our long US dollar position versus Asian currencies. Our overall long US dollar exposure (which we increased over the month) performed well in June. Our equity tail hedges on European banks and emerging markets also performed well and we took partial profits. We are currently running a defensive credit portfolio with equity tail risk hedges and no active duration positions.

Tightening liquidity conditions have been driving market weakness, and we expect this to continue for the next few months. Valuations have corrected across many credit markets, and are no longer obviously expensive in our view. But we don't think they represent good value yet given this tightening.

Julien is a portfolio manager in the Multi-Strategy Fixed Income team where he is responsible for global credit and absolute return mandates. He joined LGIM in September 2007 from Fortis Investments, where he was a quantitative strategist in the structured finance team and developed market standard and proprietary models for the pricing and risk management of credit derivatives as well as trading and hedging strategies. Julien has a PhD in financial modelling from the Ecole Normale Supérieure, Paris, France.

KEY RISKS
