OBJECTIVES AND INVESTMENT POLICY

- **Important note:** Effective from 15 February 2022, the Fund name will change to the Legal & General Future World Sustainable UK Equity Focus Fund. Other changes are also being made to the objective and policy of the Fund.  - The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 4% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.
 - The Fund is actively managed and invests at least 90% in the shares of UK Companies that the Manager believes have strong growth prospects. These are companies that are incorporated, listed, headquartered or which have their principal business activities in the UK.
 - Over a market cycle (typically 3 to 5 years), the Fund will comprise on average 25 companies in broadly equal weightings selected by the Manager following research of each company. The Fund's portfolio will be concentrated.
 - The Fund may also invest in participatory notes, preference shares, cash, deposits, money market instruments (such as treasury bills) and collective investment schemes, including those which are managed or operated by the Manager or an associate of the Manager.
 - In addition, the Fund is also permitted to receive and hold warrants and convertible bonds as a result of corporate actions.
 - The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:
 - reduce risk or cost; or
 - generate additional capital or income with no, or an acceptably low, level of risk.

- The Fund is actively managed as the Manager uses their expertise to select investments to achieve the Fund's objectives.
 - Your units will be accumulation units. Income from the Fund's investments (dividends) will be reinvested back into the value of your units.
 - You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price.
 - The Fund's base currency is denominated in sterling (British pounds).
 - This Fund is designed for investors looking for growth from an investment in company shares from the UK.
 - Although investors can take their money out at any time, this Fund may not be appropriate for those who plan to withdraw their money within five years.
 - This Fund is not designed for investors who cannot afford more than a minimal loss of their investment.
 - If you do not understand this document we recommend you seek additional information to help you decide if this Fund is right for you.

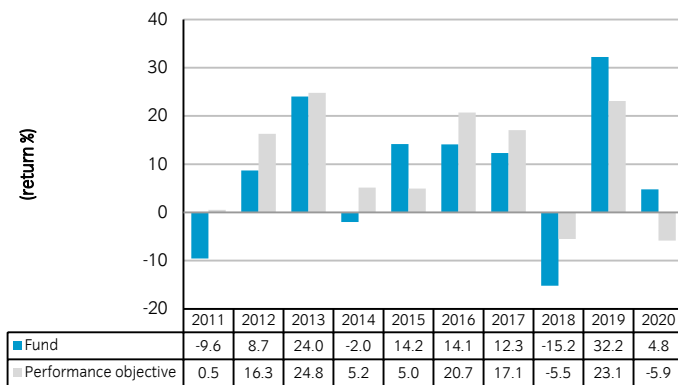

- There are no entry or exit charges.
- The ongoing charges figure is based on the latest available expenses at December 2020. This figure may vary from year to year.
- This Fund's ongoing charges include any charges made by any other funds it may invest in. They exclude portfolio transaction costs.
- The ongoing charges are taken from the income of the Fund.

Other costs:

- **Dilution Adjustment:** on any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'. This can vary but as an example for this Fund we estimate 0.59% for purchases and 0.09% for sales at 02 December 2021. The amount of the dilution adjustment may differ in future.
