FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 5 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

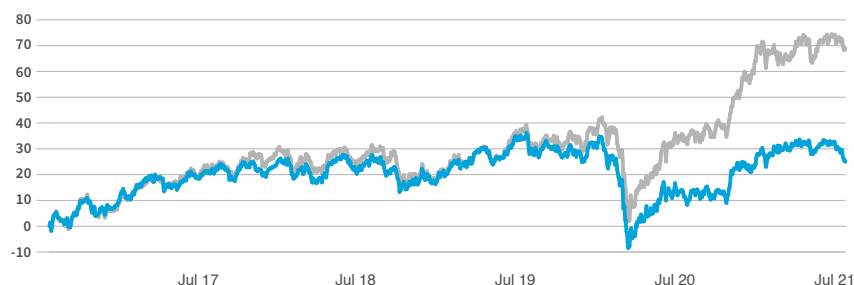

- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.

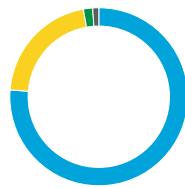



FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned -6.8% in July in GBP terms, whilst the fund outperformed the benchmark, returning -5.4%. Market weakness throughout the region spread from China following the government announcing regulatory reforms to the private tutoring sector, heightening investor concern over wider action being taken. This follows recent increased governmental scrutiny being applied to the technology sector, as well as actions taken to stabilise the housing market.

Unsurprisingly, given the regulatory concerns, China was the weakest region in the index. This made a significant positive contribution to relative performance given our underweight allocation to the country based on the weak corporate governance we find there. Our large overweight to Australia was also beneficial. The only material negative allocation impact came from our underweight in India, which was one of the strongest performing markets in index.

Sector allocation was also positive, driven by our overweight position in Telecoms, with the sector outperforming in the month. The fund also benefited from its underweight allocations to Consumer Discretionary, where the market sell-off was most severe, and Technology.

At stock level, the strongest contributions to relative fund performance came from our holding in BHP Group and not owning Tencent and Meituan. The largest negative contributions came from our holdings in Lenovo, MGM China and CIMC Vehicles.

There were no notable portfolio changes in the period.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS
