FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 5% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

FUND SNAPSHOT

- **What does it invest in?** Invests at least 80% in shares of UK companies which are considered to be undervalued by the market, where the Manager believes there to be a catalyst (a feature or market event) which should increase the value of the company.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.

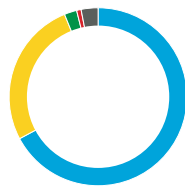

FUND MANAGER COMMENTARY

Continued positive market sentiment and broadening equity market participation drove a strong return for the UK equity market in April. The Covid-19 vaccine rollout in the UK has continued to proceed well, with 51% of the population now having received at least one dose, allowing for what looks like the start of a sustained reopening of the economy. It has been encouraging to see that Covid-19 cases remain at a low level, despite the relaxation of some restrictions. Optimism amongst investors was further fuelled by both the manufacturing and services PMI surveys coming in above 60 for April, indicating to economic growth in the UK. Beneath the headline index, the recent factor rotation trade from growth to value paused this month with growth outperforming. This was in contrast to February and March where inflation concerns and the reopening trade drove a strong value stock rally.

The L&G UK Special Situations Trust performed in line with its benchmark in April. Stock selection was positive, driven by our names in Technology and Industrials. Sector allocation was broadly neutral. At the individual stock level, top positive contributions came from our holdings in Intermediate Capital, St James's Place and Future. The largest negative contributions to relative returns came from Associated British Foods and Barclays.

In terms of new activity, we entered a new position in Darktrace, a leading cyber AI business offering exposure to the fast-growth IT security market through a differentiated product set. The IPO came at a significant discount to listed peers despite higher forecast growth rates.

ENVIRONMENTAL PERFORMANCE

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
