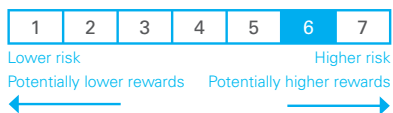

FUND AIM

The investment objective of the fund is currently to track the performance of the MSCI EM (Emerging Markets) ex Selected Securities Index (less withholding tax where applicable) to within +/-0.60% p.a. for two years out of three.

RISK AND REWARD PROFILE



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as a class 6 of the 7 due to the current lack of four years of weekly price history. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

WHO IS THIS FUND FOR?

- The trustees of UK registered defined benefit or defined contribution occupational pension schemes, which may be classified as either retail clients or professional clients.
- Although investors can take their money out at any time, the recommended minimum holding period is 5 years.

FUND CHARACTERISTICS

The fund employs an index tracking strategy, aiming to replicate the performance of its benchmark. This is a customised index comprising securities from the MSCI EM (Emerging Markets) Index excluding companies which fail to meet minimum criteria as defined in the index methodology. The exclusion criteria are guided by LGIM Environmental, Social and Governance ("ESG") research with any potential exclusions assessed for financial materiality and consistency with market capitalisation indices. As ESG terminology becomes better defined and more commonplace the exclusions are likely to develop over time, although we do not expect any changes to have a material impact on the risk and reward profile of the index. In addition, within the tracking deviation, the fund may exclude additional companies in line with LGIM's view as to minimum corporate standards and environmental policies. We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The fund may also hold index and single stock futures for efficient portfolio management.

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.

KEY RISKS
