## FUND AIM

The objective of this Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 3% per annum before charges, over rolling three year periods.

## FUND SNAPSHOT

- **What does it invest in?** Invests at least 90% in shares of UK companies. The proportion of the fund invested in a company can vary between -10% and +5% of the weighting of that company in the Index.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.



## FUND MANAGER COMMENTARY

Global equity market performance was mostly negative as volatility increased amid the resurgence of new coronavirus cases across the UK and Europe. Alongside broader uncertainty on the implications for economic recovery, the lack of fiscal stimulus ahead of the upcoming US election vote applied downward pressure on markets. Q3 corporate earnings have generally been mostly positive thus far, but the market appears more focused on Q4 guidance and the 2021 outlook. As such, good results are not necessarily being rewarded on results day.

Looking ahead to 'lockdown 2' prospects, perhaps the market may focus on what may be different this time. China is back to growth, some industries will remain open for trade, and while capital raisings may become necessary again, this may not be as well supported by investors as first time around.

The L&G UK Select Equity Fund delivered a return of -2.5% in the period, which outperformed its benchmark. Stock selection was positive, driven by gains in consumer goods and healthcare. This was offset slightly by some weakness in consumer services. Sector allocation was neutral. By individual stocks, our holdings in Watches of Switzerland, Abcam, HGCapitalTrust, Aston Martin Lagonda, Derwent London and Helios Towers all made positive contributions. On the flipside, Network International and Ocado Group were the biggest detractors.

In terms of activity, we switched the holding of oil & gas producer, BP, into mining business, Rio Tinto. We remain negative on oil prospects, but are increasingly more positive on the outlook for base metals.

Gavin joined LGIM in 2007 and has been the Fund Manager for the UK Select Equity Fund since June 2018. Previously, he was a Global Equities Analyst at BlueBay Asset Management. Gavin spent the majority of his buy-side career as a Portfolio Manager with UBS O'Connor. Prior to this, he was a top-rated, sell-side analyst covering the Autos, Capital Goods and Conglomerates sectors at investment banks including SG Warburg (now part of UBS) and Goldman Sachs. Gavin holds a degree in Philosophy and Economics from University College, London.

### CARBON RESERVES
