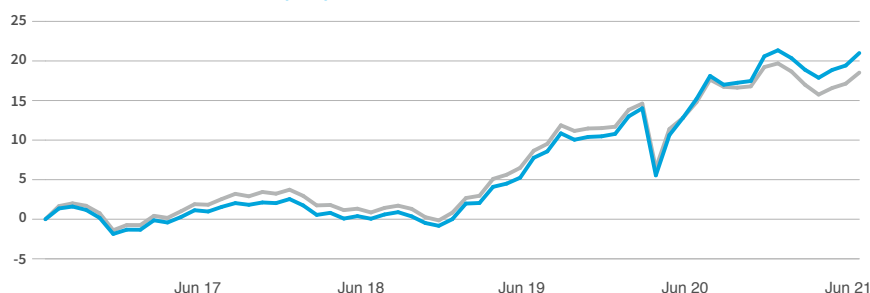
WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

The fund may achieve all or a significant amount of its exposure by purchasing shares in the LGIM Global Corporate Bond Fund which is a UCITS Compliant OEIC sub-fund. The underlying fund will principally invest in a variety of fixed, floating, index linked and zero coupon government bonds and corporate bonds, other fixed or floating debt securities that may include Asset-Backed Securities (ABS), hybrid bonds, shares in the sub-funds of LGIM Liquidity Funds Plc. and other cash and money market instruments. Currency hedging is employed by way of purchasing units in the GBP hedged share class of the fund.

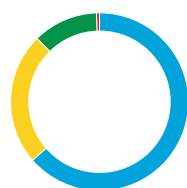

FUND MANAGER COMMENTARY

The fund outperformed the benchmark during the quarter, primarily due to favourable credit selection.

Our overweight exposure in oil and gas benefited from the increase in oil prices. Our overweights in Covid-exposed sectors such as airlines (EasyJet, Ryanair), hospitality (Whitbread), travel (Expedia), aerospace (Boeing) and autos (Ford) were also positive. Our sub-financial exposure in Europe and in the UK continued to deliver positive performance, supported by prospects of stronger growth in those regions. We had notable positive contributions from Syngenta and Credit Suisse. The underweight in US dollar credit was a negative contributor over the quarter. Rates strategies also detracted, primarily driven by our tactical short position in US 10-year rates. Credit default swap tail risk hedging strategies were also negative.

We continue to focus on rates markets and on the potential effects of a pickup in volatility here on credit spreads. In this environment, we were comfortable maintaining an overweight in credit beta throughout the quarter, driven by strong demand for credit offsetting tight valuations. We maintain our preference for Pan-European over US dollar credit. We continue to hold overweights in emerging market debt and in high yield which we see as more attractive areas than developed market investment grade.
