FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE World Europe ex-UK TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

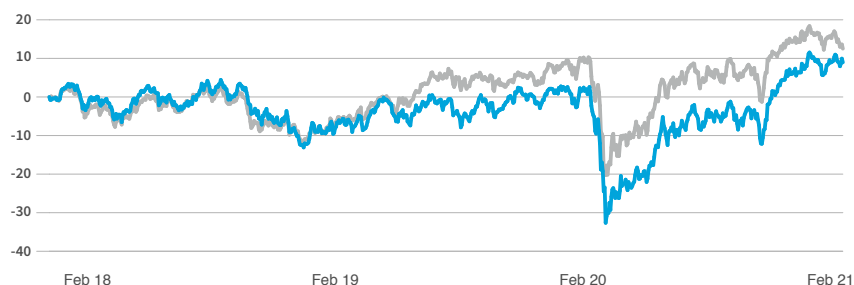

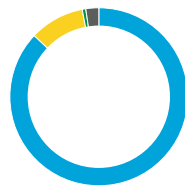

FUND MANAGER COMMENTARY

European equities produced a positive return in February. Beneath the surface, volatility continued from January, with rising rates and the reopening trade resulting in value and cyclical stocks enjoying a strong month. Financials and Oil & Gas stocks were particularly strong. Growth and quality names continued to underperform, continuing the factor rotation that began towards the end of January. Investors are closely monitoring oil prices, which continued to gain momentum, returning +20% in the period. Concerns remain on the EU lagging the rate of vaccine roll out in other developed regions such as the UK and US. The market will be monitoring progress towards the goal of vaccinating 70% of the adult population by summer. In the meantime, many countries are extending selective lockdowns. In terms of company results, earnings season has for the most part surpassed analyst expectations across the board. However, given the volatility, market reactions have varied. The L&G European Equity Income fund delivered returns that outperformed its benchmark in February. Stock selection contributed to the outperformance, led by our names in Financials and Consumer Services. Sector allocation also positively contributed to relative returns, driven mainly by our underweight position in Utilities and overweight in Financials. At the stock level, the strongest positive contributors included Societe Generale, Norsk Hydro and Rexel. Notable underperformers were Wackie Chemie and EDP. There were no notable portfolio changes in the period.

He started his career at Phillips & Drew in 1992, where he spent 10 years investing in UK, European and Japanese Equities. He has an MA in PPE from New College, Oxford. CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its salesⁱⁱ.
