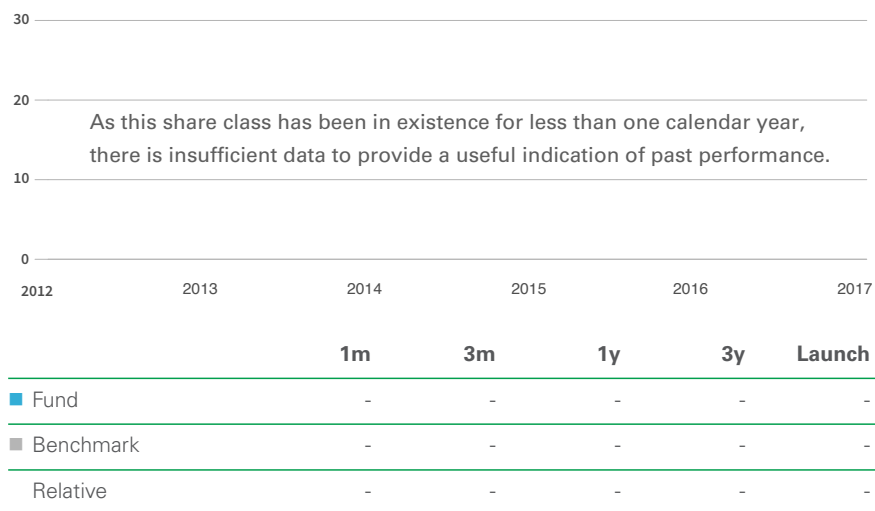

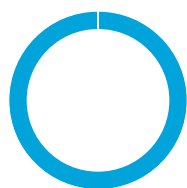

FUND MANAGER COMMENTARY

Emerging market debt had a very strong month in January driven by a substantial rally in global financial markets and strong inflows into the emerging market debt asset class. The EMBIG Diversified sovereign index returned 4.41% (with spreads tightening by 57bps) and the CEMBI Broad Diversified corporate index returned 2.82% (with spreads tightening by 37bps).

Sovereign bonds significantly outperformed corporate bonds over the month which positively impacted the fund's relative performance given our overweight in sovereigns. Within the corporate space, our bond selection in the financial, metals & mining and oil & gas sectors contributed positively to the fund's relative performance. In sovereigns, our overweight in Argentina, the Ukraine and Venezuela helped the fund's performance. However, our underweight in Central and Eastern Europe and Asia contributed negatively amid an environment of rallying US treasuries.



UDAY PATNAIK

Uday is responsible for developing LGIM's emerging market capabilities within the Multi-Strategy Fixed Income team. Uday joined LGIM in April 2014 from Gulf International Bank (UK) Ltd where he held the title of Chief Investment Officer with primary responsibility for managing the flagship EMD hedge fund and other fixed income portfolios. Uday has an MBA in finance from the University of Chicago and a BSc degree in industrial management from Carnegie Mellon University.

KEY RISKS

- This fund holds bonds that, rather than being traded on an exchange, are traded through agents, brokers or investment banks matching buyers and sellers.
