What is the product?

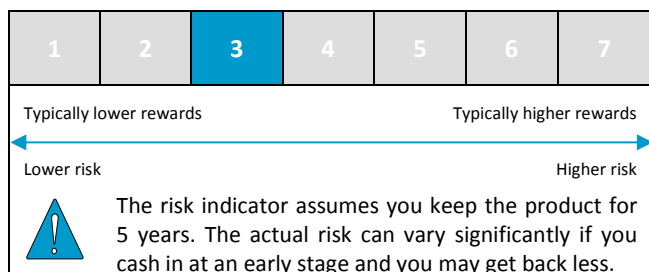
Type: This investment fund is a Unit Linked Fund within a life insurance policy.

Objectives: The fund aims to achieve growth of capital and provide income. Income from investments will be reinvested into the fund. The investment objective of the fund is currently to track the performance of the JPMorgan Global Government (ex UK) Traded Bond Index to within +/-0.50% p.a. for two years out of three.

The constituents of the index are bonds, i.e. debt issued by global governments, excluding the UK, issued in a range of currencies. The fund invests primarily in fixed interest securities, where income is pre-set at a fixed level. The index includes securities that are investment grade, i.e. rated as lower risk. Investment grade bonds have achieved a higher credit rating (BBB- and above) from a recognised rating agency. Third party credit ratings give an indication of how likely it is that an issuer of a bond will be able to fulfil its contractual obligations to pay back interest and capital on the loan on time. The credit rating methodology is defined by the provider of the benchmark. The index is weighted based on the eligible bonds in issue, as defined by the index provider. The fund applies a pragmatic approach to managing the fund and will replicate the index within defined risk tolerances. The fund's investments will closely match the index constituents either investing directly in the securities, or indirectly through other LGIM funds.

Intended retail investor: The trustees of UK registered and certain non-UK registered defined benefit or defined contribution occupational pension schemes, which may be classified as either retail clients or professional clients.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as class 3 out of 7, which is a medium-low risk class.

This summary risk indicator is based on historical data which may not be a reliable indication of the fund's risk category in the future.

The category is based on the rate at which the value of the fund has moved up and down in the past.

The fund's category is not guaranteed to remain the same and may change over time.

Even a fund in the lowest category is not a risk free investment.

There is no Policy Charge if the aggregate investments you have within the life insurance policy is over 25,000,000 GBP. The figures do not take into account your personal tax situation, which may also affect how much you get back.

Market developments in the future cannot be accurately predicted. The scenarios shown are only an indication of some of the possible outcomes based on recent returns. Actual returns could be lower.

What happens if Legal and General Assurance (Pensions Management) Limited is unable to pay out?

PMC's floating charge is intended to operate to protect PMC policyholders, by maximising their likely recoveries, if PMC were to become insolvent. In addition, in the event of PMC's insolvency certain PMC policyholders may be able to recover up to 100% of any deficit (any shortfall of the value of a valid claim for any loss incurred after the operation of PMC's floating charge) from the FSCS. Please note that PMC policyholders would have to meet the relevant FSCS eligibility criteria to claim. Your ability to claim and the amount you may be able to claim under the FSCS will depend on the specific circumstances of your claim. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs, but exclude the Policy Charge relevant to you.

The amounts shown here are the cumulative costs of the Fund, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10,000 GBP. The figures are estimates and may change in the future.

The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs and show you the impact that all costs will have on your investment over time.

	Exit costs	0%	The impact of the costs of exiting your investment when it matures.
Ongoing costs	Portfolio transaction costs	-0.04%	The impact of the costs of us buying and selling underlying investments for the product.
	Other ongoing costs	0.15%	The impact of the costs that we take each year for managing your investments.
Incidental costs	Performance Fee	0%	The impact of performance fees. We take these from your investment if the product outperforms its benchmark.

How long should I hold it and can I take my money out early?

Recommended minimum holding period: 5 years
