FUND AIM

The investment objective of the fund is to provide long-term investment growth through dynamic exposure to a diversified range of asset classes. The long-term expected annualised rate of return for this fund is the Bank of England Base Rate +4.5% per annum, over a full market cycle.

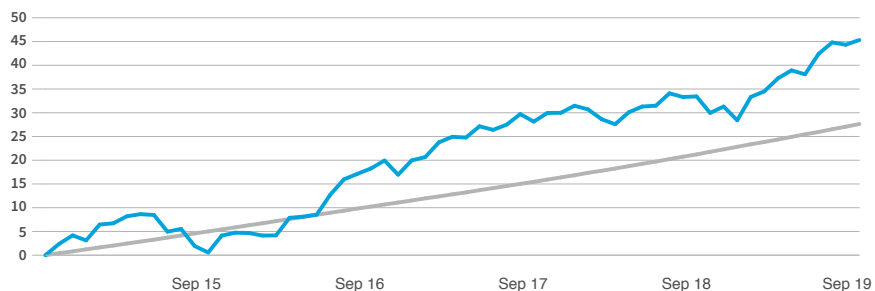
WHO IS THIS FUND FOR?

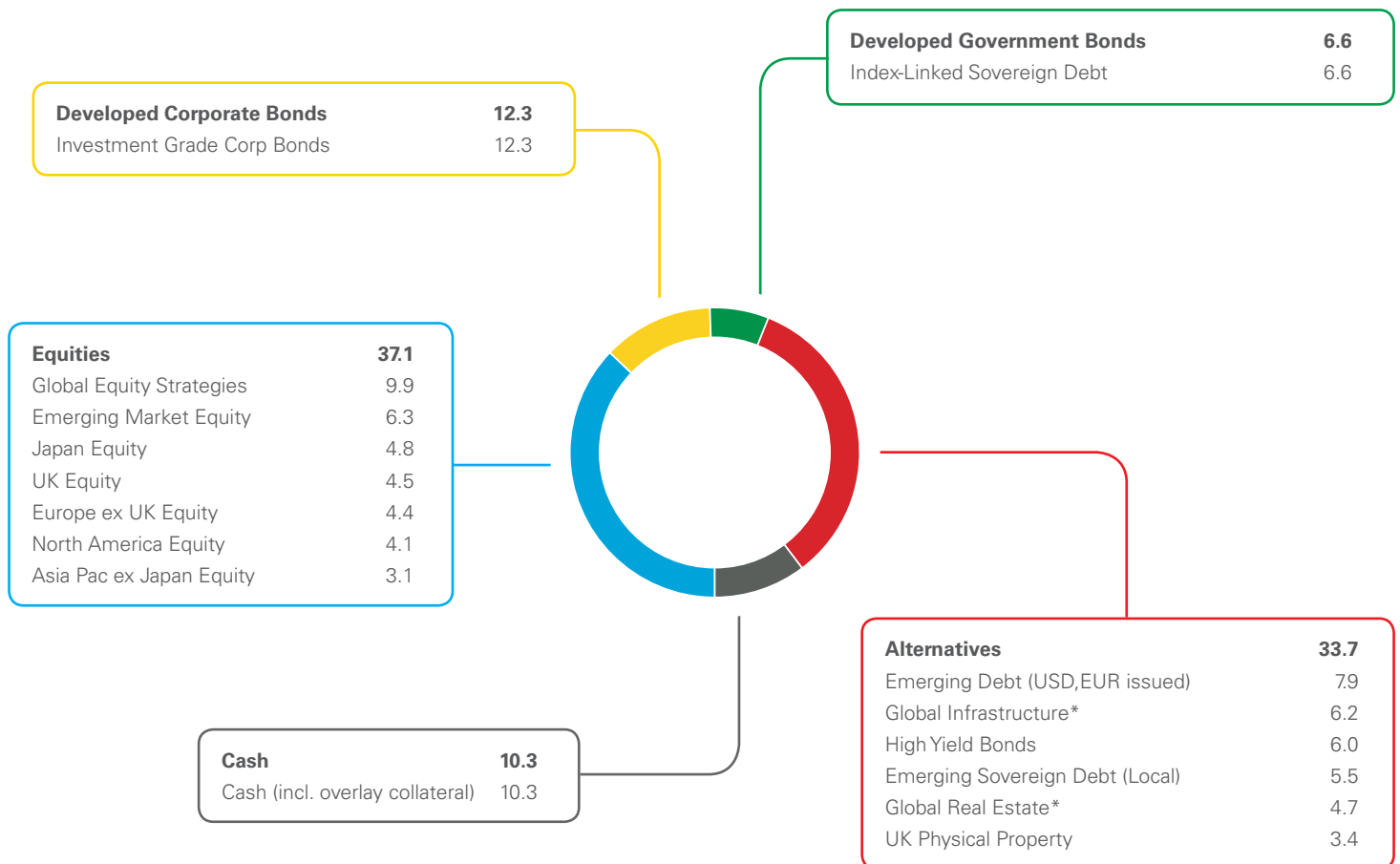
FUND CHARACTERISTICS

The fund provides exposure to a range of different asset classes including equities, bonds, property, commodities and listed infrastructure, private equity and global real estate companies, which may be actively or passively managed. The asset allocation of the fund is managed by LGIM with the aim of enhancing returns and managing downside risk. The fund provides exposure to a combination of UK and overseas assets with a flexible approach taken to managing foreign currency exposure.

Derivatives may be used for efficient portfolio management.

FUND MANAGER COMMENTARY

The LGIM Dynamic Diversified Fund returned 2.0% over the quarter. This brings the total return since inception to 7.7% per annum versus an objective of 5.0% per annum.

The main contributions to performance came from US inflation-linked bonds, factor-based equities, and listed global real estate. In terms of detractors, currency hedging, option positions, hedges on global rates exposure via bond futures, and emerging-market equities weighed on performance.

We have increased the level of option protection in the fund, specifically in relation to Eurozone equities as they have performed relatively well this year and the region is one of the most vulnerable in an economic downturn scenario. We also started to direct new cashflow into the fund to the Future World equity index funds (based on LGIM's ESG scores for constituents, these funds tilt their stock weightings relative to a market-capitalisation approach) rather than standard equity index funds. Finally, we exited our US energy position due to the political risk associated with Donald Trump attempting to push down the oil price to increase his likelihood of re-election in the US and we took profits on our Mexican equity position.

With a deteriorating economic backdrop, we have increased the fund's duration through a combination of scaling back our hedge on UK rates and also adding duration in the US and Europe.

FUND MANAGERS

The Fund is managed by LGIM's Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM's client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
