The objective of the Fund is to generate long term capital growth above that of the MSCI World Total Return Net Index, the "Benchmark Index". The Fund is actively managed and aims to outperform the Benchmark Index by 3% per annum. This objective is before the deduction of any charges and measured over rolling three year periods. There can be no assurance that the Fund will achieve its investment objective.

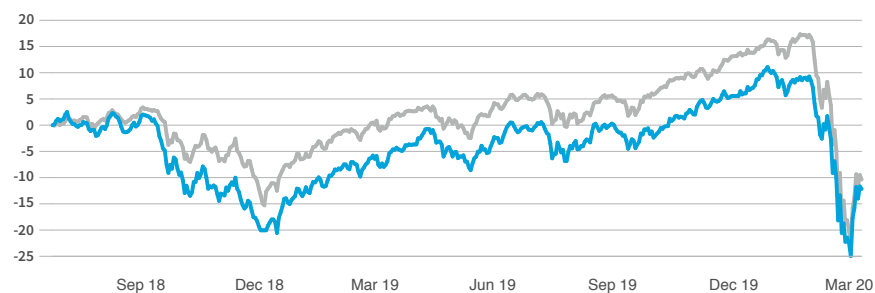

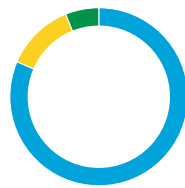

## ESG COMMITMENT

ESG score of fund

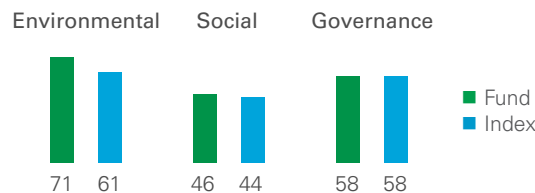


ESG score of index

### ESG SCORE

We score companies based on environmental, social and governance factors. The ESG Score is aligned to our engagement and voting activities. As a result, this portfolio has an aggregate ESG Score of **56** versus a mainstream index of **52**.

This portfolio is constructed through bottom-up fundamental analysis where ESG is fully integrated into stock selection. This qualitative approach contrasts with a systematic approach and is designed to be forward looking, investing in companies with materially improving ESG characteristics. ## ENVIRONMENTAL PERFORMANCE

Carbon dioxide (CO<sub>2</sub>) is the most significant contributor to greenhouse gas emissions which are driving climate change. Compared to a fund tracking the unadjusted benchmark, the fund will have a different exposure to current and future sources of carbon dioxide emissions.

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figures below are a measure of the size of carbon reserves held by the fund's underlying companies.

The fund has **100%** lower carbon reserves intensity<sup>ii</sup> compared to a fund tracking the unadjusted benchmark.

The difference in carbon reserves intensity means that for every \$1 million invested in the fund, the exposure to fossil fuels through the underlying companies is reduced by an amount equivalent to **3,462 barrels of oil<sup>iii</sup>**, compared to having invested in the unadjusted benchmark.

### CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

**25 Fund**      **172 Benchmark**      **Tonnes of CO<sub>2</sub>e per \$1 million of sales**

The fund has **85%** lower carbon emissions intensity compared to a fund tracking the unadjusted benchmark. Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>v</sup>.

The difference in carbon emissions intensity means that the fund has selected companies where, for the same level of sales, the associated emissions<sup>v</sup> are lower by **85%** compared to a fund tracking the unadjusted benchmark<sup>vi</sup>.

**NOTES**

<sup>i</sup> Carbon dioxide equivalent (CO<sub>2</sub>e) is a standard unit to compare the emissions of different greenhouse gases.

<sup>ii</sup> The carbon reserves intensity of a company captures the relationship between the carbon reserves the company owns and its market capitalisation. The carbon reserves intensity of the overall fund reflects the relative weights of the different companies in the fund.

<sup>iii</sup> We consider one barrel of oil equivalent to 0.425 tonnes of CO<sub>2</sub>e, based on International Energy Agency and Intergovernmental Panel on Climate Change guidelines.

<sup>iv</sup> The choice of this metric follows best practice recommendations from the **Task Force on Climate-related Financial Disclosures**.

<sup>v</sup> Data on carbon emissions from a company's operations and purchased energy is used.

<sup>vi</sup> This measure is the result of differences in the weights of companies between the index or the fund and the benchmark, and does not depend on the amount invested in the fund. It describes the relative 'carbon efficiency' of different companies in the index (i.e. how much carbon was emitted per unit of sales) or in the fund, not the contribution of an individual investor in financing carbon emissions.

We use a proxy benchmark to represent a typical comparable universe for this fund. The proxy benchmark may not replicate the performance benchmark should the fund make reference to one.

The ESG Score is aligned to our engagement and voting activities. Therefore the current ESG score of the portfolio may not fully reflect the positive characteristics of the portfolio over and beyond current disclosure.

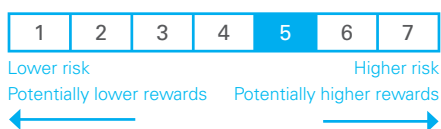

## RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.
