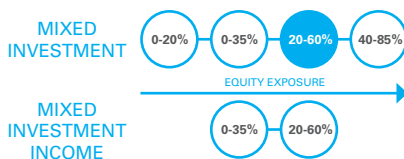

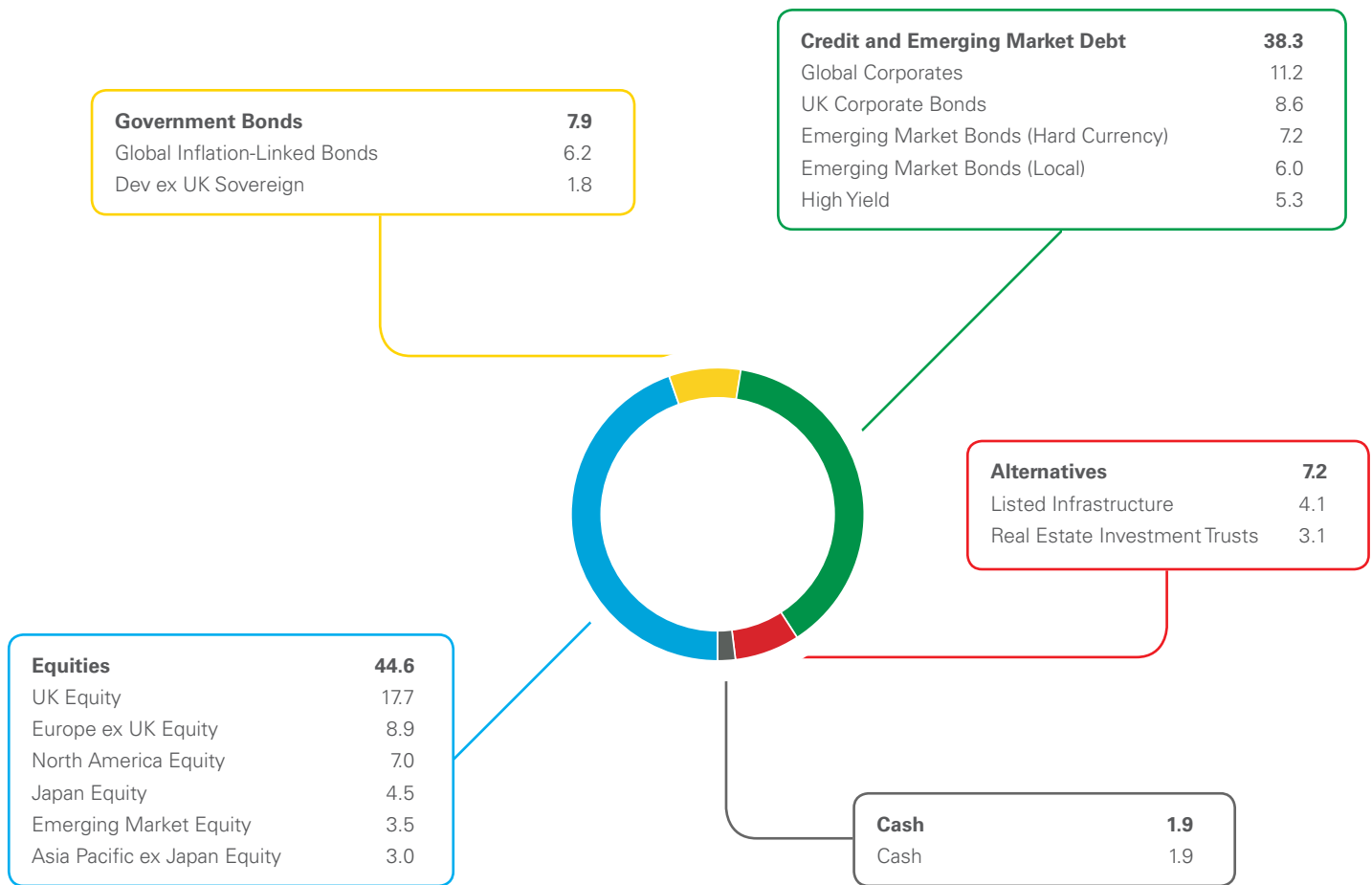
## FUND SNAPSHOT

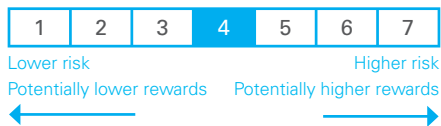
### FUND MANAGERS

## RISK AND REWARD PROFILE

## KEY RISKS
