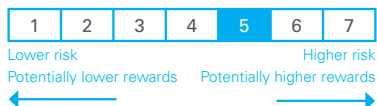

## FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

## RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 5 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

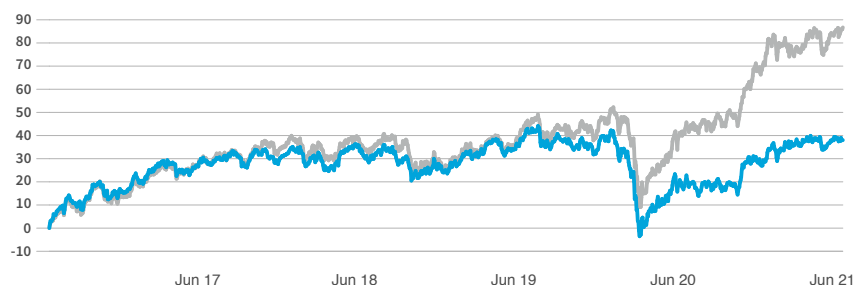

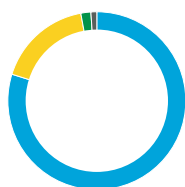

## FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned 2.6% in June in GBP terms whilst the fund returned 1.0%. The positive market return in the month came amid continued investor optimism for a return to economic normality, with the ramping up of vaccine initiatives worldwide.

Macau was one of the weakest regions in the index, due to slow recovery of the gaming and tourism sector as a result of prolonged travel restrictions. Our overweight allocation to Macau therefore had a negative impact. The fund also experienced a negative contribution to relative performance from Australia lagging the broader index, given our overweight allocation to the country. Stronger performing regions included South Korea, where economic growth forecasts were upgraded, and India, due to investor optimism that Covid cases in the country have peaked.

Sector allocation was negative, driven by our underweight positions in Technology and Consumer Discretionary, with both of these sectors outperforming in the month. This was partially offset by an overweight allocation to Industrials, with this sector also performing strongly in the context of global economic recovery.

At stock level, the strongest contributions to relative fund performance came from PetroChina, CIMC Vehicles and not owning Tencent. The largest negative contributions came from our holding in KT Corp and not owning Alibaba and NIO.

There were no notable portfolio changes in the period.



### PAUL HILSLEY

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

## ENVIRONMENTAL PERFORMANCE

Carbon dioxide (CO<sub>2</sub>) is the most significant contributor to greenhouse gas emissions which are driving climate change.

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

### CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>ii</sup>.


