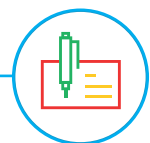

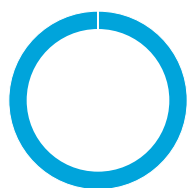

FUND MANAGER COMMENTARY

Emerging market debt continued its march up in April, driven by a continued risk-on tone in global financial markets and further inflows into the asset class during the month. Total returns were reduced due to higher US treasury yields (10-year yields moved 10bps higher in April.) The EMBIG Diversified sovereign index returned 0.24% (with spreads tightening by 10bps) and the CEMBI Broad Diversified corporate index returned 0.84% (with spreads tightening by 1bps).

Within the broader corporate space, our bond selection in the oil and gas sector contributed positively to the fund's relative performance. In the sovereign space, our overweight positions in Argentina negatively affected the fund's performance. However, our overweight in Africa contributed positively.

Uday is responsible for developing LGIM's emerging market capabilities within the Global Fixed Income team. Uday joined LGIM in April 2014 from Gulf International Bank (UK) Ltd where he held the title of Chief Investment Officer with primary responsibility for managing the flagship EMD hedge fund and other fixed income portfolios. Uday has an MBA in finance from the University of Chicago and a BSc degree in industrial management from Carnegie Mellon University.
