FUND AIM

The investment objective of the fund is to provide long-term investment growth through dynamic exposure to a diversified range of asset classes. The long-term expected annualised rate of return for this fund is the Bank of England Base Rate +4.5% per annum, over a full market cycle.


WHO IS THIS FUND FOR?


FUND CHARACTERISTICS

The fund provides exposure to a range of different asset classes including equities, bonds, property, commodities and listed infrastructure, private equity and global real estate companies, which may be actively or passively managed. The asset allocation of the fund is managed by LGIM with the aim of enhancing returns and managing downside risk. The fund provides exposure to a combination of UK and overseas assets with a flexible approach taken to managing foreign currency exposure.

Derivatives may be used for efficient portfolio management.

FUND MANAGER COMMENTARY

Market headlines over the quarter were dominated by escalating concerns over European politics and trade conflict between the US and China. However, this didn't result in universally poor performance for risk assets. Emerging market assets and European peripheral debt were the worst performing assets. However, UK and US equities performed well, REITs and listed infrastructure turned around their disappointing start to the year, while European and Japanese equities edged higher. The decline in sterling was notable, helping to boost returns on unhedged overseas assets. In fixed income markets, there was a clear upward trajectory in US interest rates, while pan-European rates generally fell in response to caution from the European Central Bank.

The Dynamic Diversified Fund delivered positive returns in the second quarter. The main contributions to the fund's return came from equity markets, listed alternatives and fixed income. However, this was partially offset by emerging market exposure and a negative performance from currency hedges. Option protection contributed positively to performance.

We increased emerging market exposure via the Mexican peso and Russian rouble, as well as through targeted issuers in external (hard currency) sovereign debt. Throughout the second quarter we moderated our US dollar position by reducing euro hedging and establishing some protection against a recovery in the pound through options. Duration exposure was reduced via hedges in gilts and US long-dated bonds, as well as option protection on US ten-year bonds.

FUND MANAGERS

The Fund is managed by LGIM's Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM's client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
