FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

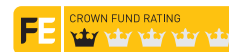

- **How does it invest?** Actively managed, with holdings in between 40 and 60 companies on average over a typical market cycle of 3-5 years.

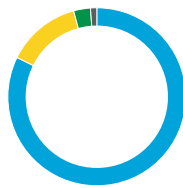

FUND MANAGER COMMENTARY

December confirmed the strong performance of global equities in 2019. The biggest market event was seen in the UK, where the general election outcome was favourable for domestic-focused equities, as Boris Johnson's Conservative party won by a clear majority. Elsewhere, markets also benefited from the reaction to the latest announcement of a phase 1 agreement between the US-China, as tensions moderated over the trade deal. Meanwhile, economic data continues to hold out. Finally, the Bank of England and Fed opted to keep central bank policy rates on hold. The Fed signalled they would likely remain so through 2020.

In respect of equity market performance, style factors continue to deviate regionally, though the Q4 rebound for Cyclical and Financials in the UK continued. Miners also enjoyed a better month. By size, Large-caps were weak on a relative basis, given mid and small-cap gearing to Brexit positivity. Value once more advanced, though Quality also fared well.

The L&G UK Equity Income reported a positive return of 3.3%, which performed in line with its benchmark. Once again, the reprisal of the Value style helped the portfolio, even if it was less pronounced than recent months. Leading contributors had a domestic bias, led by our general retail exposure. There was also outperformance from Carnival, Imperial Brands, RBS Group, Jupiter Fund Management and Whitbread. The biggest underperformer was Micro Focus International. Finally, in a quiet month for trading, we exited small positions in Chemring and Johnson Matthey, given a lack of conviction.



STEPHEN MESSAGE

Stephen joined LGIM in 2017 as a Fund Manager for the UK Equity Income portfolios. He has been managing the UK Equity Income Trust since November 2017.
