FUND AIM

The investment objective of the fund is to provide diversified exposure to UK and overseas equity markets while minimising foreign currency exposure. The fund will invest 60% in the UK and 40% overseas. The fund's overseas asset distribution is fixed with 14% in North America, 14% in Europe (ex-UK), 7% in Japan and 5% in Asia Pacific (ex-Japan).

FUND CHARACTERISTICS

The fund achieves its objectives by investing in a range of LGIM index tracking funds. The underlying funds employ an index tracking strategy, aiming to replicate the performance of their individual benchmarks. We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The funds may also hold index and single stock futures for efficient portfolio management. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the fund. Currency exposure of any advanced emerging markets will not be hedged.

Composite of 60/40 distribution between UK and overseas - GBP Hedged

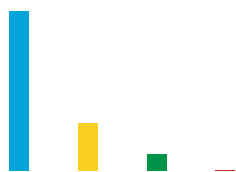

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.
