FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.

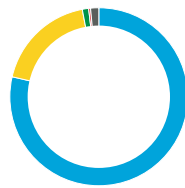

FUND MANAGER COMMENTARY

By country, India was the strongest performing, with market optimism around the rate of COVID-19 infections beginning to stabilise. Despite this, the country is still experiencing higher infection rates than many others. This strong performance negatively impacted fund performance given our underweight allocation to India. New Zealand was one of the weakest regions, and although the fund has an overweight allocation to the country, strong stock selection offset this. China continued to lag the broader index with investor concerns remaining around moderate policy tightening and tougher regulations on the technology sector. This made a positive contribution to relative performance given our underweight allocation to the country based on the weak corporate governance we find there.

Sector allocation was positive, driven by our underweight positions in Technology and Consumer Discretionary, with both of these sectors underperforming in the month. This was partially offset by an underweight allocation to Healthcare, with this sector performing strongly.

At a stock level, the strongest contributors to relative fund performance came from our holdings in KT Corp and Coway. Not owning Alibaba was also beneficial. The largest negative contributions came from our holdings in Lenovo and SJM Holdings.

There were no notable portfolio changes in the period.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS
