FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

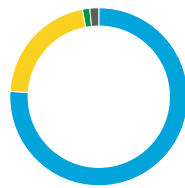

FUND MANAGER COMMENTARY

The UK equity market continued its recent upward trend in December. Although somewhat less dramatic than the previous month's movements, markets were in a favourable mood ahead of the festive holiday period. The value factor had a strong start to the month, with growth and quality cyclicals founding favour once again later on in the period. On the news front, the market reacted positively to the UK and EU finally agreeing a trade deal, over four and a half years after the Brexit referendum result. Elsewhere, the roll out of the Pfizer vaccine commenced, along with the news that the UK has also approved the Oxford/AstraZeneca vaccine for use. The next few months will be critical, with coronavirus cases currently rising sharply, bringing expectations of further lockdown measures. For sector performance, we saw the more cyclical areas such as Basic Materials, Industrials and Financials enjoyed a strong month for price action.

The L&G UK Equity Income Fund outperformed against its benchmark in December. Stock selection positively contributed to the outperformance, with particular strength in Consumer Goods and Industrials. Sector allocation also made a positive contribution, driven by the underweight positioning in Health Care and Consumer Goods. By stock, the strongest performers were Meggitt, Imperial Brands and BT Group. Underperforming names included Phoenix Group, DCC and BAE Systems.

In terms of new activity, the fund sold out of its position in sports and online gaming business, Entain.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
