



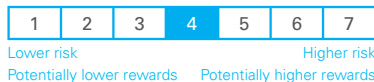

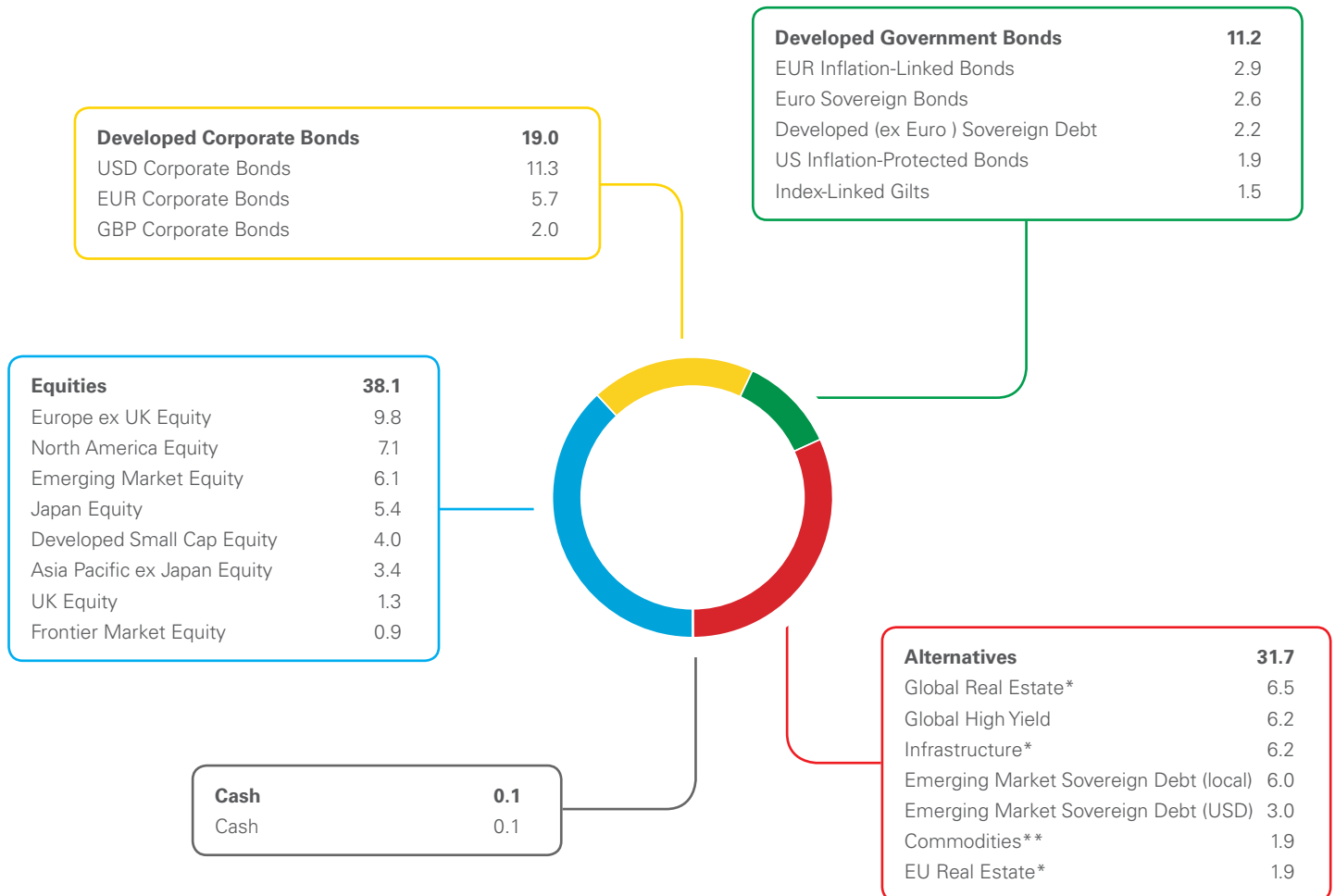

KEY RISKS
