

FUND AIM

The investment objective of the fund is currently to track the performance of the MSCI Pacific ex Japan ex Selected Securities Index- GBP Hedged (less withholding tax where applicable) to within +/-0.60% p.a. for two years out of three.



WHO ISTHIS FUND FOR?

- The trustees of UK registered defined benefit or defined contribution occupational pension schemes, which may be classified as either retail clients or professional clients.
- Although investors can take their money out at any time, the recommended minimum holding period is 5 years.

FUND CHARACTERISTICS

The fund employs an index tracking strategy, aiming to replicate the performance of its benchmark. The index is a customised index that excludes selected companies with activities in relation to areas for example, but not limited to, controversial weapons and thermal coal. Within the tracking deviation, the Fund aims to exclude companies in line with LGIM's view as to minimum corporate standards and climate engagement policies. The exclusion criteria are guided by, but not limited to, LGIM Future World Protection List with any potential exclusions assessed for financial materiality and alignment with the overall Fund objective. We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The fund may also hold index and single stock futures for efficient portfolio management. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the fund.
