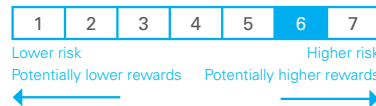

FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

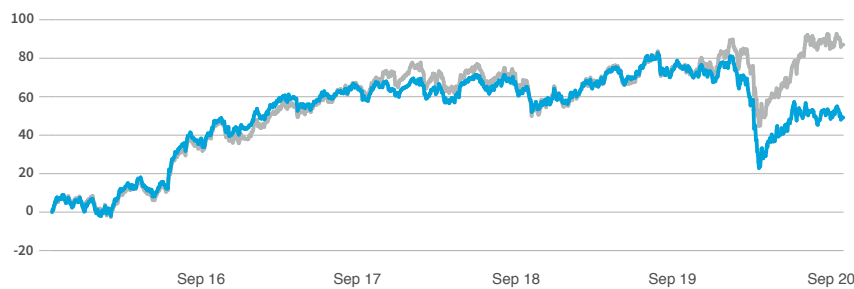

- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.

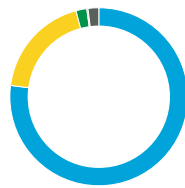

FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned +1.2% in September in GBP terms. The fund returned -1.4% over the month. From a style perspective, growth continued to outperform value.

South Korea, Taiwan and India led the index's performance. Our underweight allocation to South Korea and India, along with poor stock selection in these countries, hurt. Yet underperformance was mainly driven by stock selection in China, where not owning the zero yielding Alibaba negatively contributed, as did owning China Mobile and Petrochina.

Turning to sectors, stock selection within Consumer Services detracted. This was particularly the case for our Macau casino gaming holdings (such as SJM Holdings, MGM China and Melco Resorts). After a strong run in August, and ambitious estimates being factored in for the Golden Week holiday which later disappointed, these stocks gave back some ground. Performance was helped however by strong stock selection in Australia and New Zealand, particularly within Industrials (Transurban and Fletcher Building) and also Qantas Airways. The biggest contributor to excess return over the period was TSMC (our largest holding).

September was not an active month in terms of portfolio trading.

He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
