FUND AIM

The investment objective of the fund is to provide long-term investment growth through dynamic exposure to a diversified range of asset classes. The long-term expected annualised rate of return for this fund is the Bank of England Base Rate +4.5% per annum, over a full market cycle.


WHO IS THIS FUND FOR?

FUND CHARACTERISTICS


The fund provides exposure to a range of different asset classes including equities, bonds, property, commodities and listed infrastructure, private equity and global real estate companies, which may be actively or passively managed. The asset allocation of the fund is managed by LGIM with the aim of enhancing returns and managing downside risk. The fund provides exposure to a combination of UK and overseas assets with a flexible approach taken to managing foreign currency exposure.

FUND MANAGER COMMENTARY

The third quarter was generally kind to multi-asset investors, with various crises only having a localised impact. President Trump imposed new tariffs on Chinese goods, Argentina and Turkey experienced financial crises, while Italy’s new fiscal plan worried European investors. However, US growth was strong and the Federal Reserve stuck to its quarterly rate hike. Global equity performance was marked by US outperformance. Emerging markets (EM) were broadly flat overall, while UK equities were the laggards amid ongoing uncertainty regarding Brexit negotiations. Most sovereign bond markets delivered modestly negative returns as yields rose amid solid economic data. However, high yield and EM hard-currency debt posted small positive returns.

The Dynamic Diversified Fund delivered positive returns over the period. Traditional equity indices and factor-strategy equities made approximately equal contributions to fund returns, while high yield bond exposure also added to returns.

This quarter, we took profits on our European option protection and replaced it with additional protection on the more buoyant US equity markets. We also took profits on a series of equity positions: we reduced the tactical position in US equities we established earlier this year, reduced our relative preference for Indian equities versus emerging market equities, and removed our preference for developed equities over emerging market equities. We took advantage of weaker emerging market sentiment by adding to debt exposure. We trimmed our exposure to the Mexican peso following gains on the back of optimism regarding the new president.

FUND MANAGERS

The Fund is managed by LGIM’s Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM’s client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
