FUND MANAGER COMMENTARY

July was a much better month for risk assets. Equity markets were broadly higher, but the strength was most notable across parts of the credit space that had been under considerable pressure in recent months, particularly emerging markets. Corporate earnings have been supportive, while the technical backdrop also improved for credit markets, with supply undershooting expectations and market outflows easing considerably.

The fund delivered positive returns in July, with our holdings in investment grade and emerging market bonds proving beneficial for performance. However, our short CDS positions in investment grade credit and commodity and automobile names detracted from performance slightly amid the market rally. Overall, the credit return over the month was positive and we continue to run a defensive portfolio. Elsewhere, we entered short duration positions at the front end of the US treasury curve. The trades performed well and we continue to hold them. In currency markets, our US dollar, short emerging market positions detracted from performance. Our equity tail risk hedges also detracted from performance as equity volatility declined materially.

Looking ahead, we suspect that the recent market strength will prove temporary. Corporate issuance should increase following the second quarter earnings season and the summer holidays. In addition, central banks are likely to continue tightening policy across the globe. Finally, geopolitical tensions remain high, with Italy, Brexit and trade tariffs all important topics.

Julien is a portfolio manager in the Multi-Strategy Fixed Income team where he is responsible for global credit and absolute return mandates. He joined LGIM in September 2007 from Fortis Investments, where he was a quantitative strategist in the structured finance team and developed market standard and proprietary models for the pricing and risk management of credit derivatives as well as trading and hedging strategies. Julien has a PhD in financial modelling from the Ecole Normale Supérieure, Paris, France.

KEY RISKS
