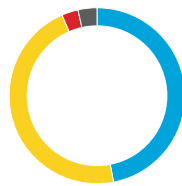

FUND MANAGER COMMENTARY

It was a month of gains for most major equity markets as risk levels returned to normalised levels. Risk appetite appears healthy, with confidence in growth from the global economy and corporate profits close to historic peaks. Some spectators have recently argued for a market correction on the basis of technicals & valuations looking stretched, peaking PMI momentum, complacency in respect of vaccines and traditional 'sell in May' rhetoric. Bullish equity momentum may begin to see fatigue, however, given the growth-policy trade off is likely to remain supportive, we would not expect any market pullback to be sustained ahead of a period of economic recovery in the coming quarters.

Turning to equity performance, the interesting ebb and flow of style returns varied throughout the month. While it is clear cyclicals have grown in popularity at the expense of momentum and defensive factors, companies with prospects of sustainable growth continue to find favour.

The L&G Growth Trust delivered a positive return in April and outperformed its benchmark by 110bps. Stock selection and sector allocation both made a positive contribution. The overweight positioning in Industrials and underweight to Financials and Energy added value. For selection, we saw relative strength within our Consumer Staples exposure. At the stock level we saw FeverTree Drinks, RWS Holdings, Just Eat Takeaway, 3i Group and Experian outperform. Elsewhere, HomeServe and Aston Martin Lagonda were the largest detractors. On trading activity, we introduced a new position in video gaming outsourcing specialist Keywords Studios, while the holding of diversified financial data business LSE Group was sold.

CARBON RESERVES
