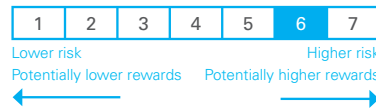

FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 5% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

FUND SNAPSHOT

- **What does it invest in?** Invests at least 80% in shares of UK companies which are considered to be undervalued by the market, where the Manager believes there to be a catalyst (a feature or market event) which should increase the value of the company.
- **How does it invest?** Actively managed, with holdings in between 30 and 60 companies on average over a typical market cycle of 3-5 years, which means the fund may be concentrated at times.

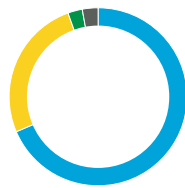

FUND MANAGER COMMENTARY

The UK equity market continued its recent upward trend in December. Although somewhat less dramatic than the previous month's movements, markets were in a favourable mood ahead of the festive holiday period. On the news front, the market reacted positively to the UK and EU finally agreeing a trade deal, over four and a half years after the Brexit referendum result. Elsewhere, the roll out of the Pfizer vaccine commenced, along with the news that the UK has also approved the Oxford/AstraZeneca vaccine for use. The next few months will be critical, with coronavirus cases currently rising sharply, bringing expectations of further lockdown measures. For sector performance, we saw the more cyclical areas such as Basic Materials, Industrials and Financials enjoyed a strong month for price action.

The L&G UK Special Situations Trust outperformed against its benchmark in December. Stock selection contributed entirely to the outperformance, with strong performance in Consumer Goods, Basic Materials and Financials. Sector allocation was neutral overall, with weakness from the underweight positioning in Basic Materials being offset by the underweight in Health Care and overweight in Industrials. At the individual stock level, the top performers included Cairn Energy, DS Smith and Prudential. Underperforming names included Energean and RWS Holdings.

In terms of new activity, we entered a number of new positions. These included Direct Line, a personal insurance business benefitting from a depressed claims environment and robust pricing, and information analytics company RELX, a long-term structural compounder.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
