FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.

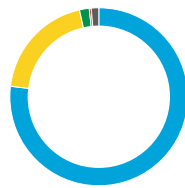

FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned +6.1% in November in GBP terms. The fund outperformed its benchmark, returning +11.8%. Positive news on COVID-19 vaccine trials resulted in value outperforming growth which benefitted our value style.

Basic Materials and Financials led the market rally, whilst Consumer Services and Technology were the worst performing sectors. Our underweight position in the latter two sectors positively contributed to fund performance.

By country, Australia, where we are overweight due to the significantly better disclosure and corporate governance versus the rest of the region, outperformed the broader index in the month. China, where we are underweight, was the worst performing market in the index. The fund therefore also benefitted from country allocation.

Relative country and sector positioning delivered positive asset allocation performance, however the largest contributor to outperformance was on the stock selection side within those regions and industries. In the month, Qantas Airways was our strongest contributor. The share price rallied on hopeful vaccine news and domestic border re-openings. Given the strong performance, we trimmed our position in order to reduce risk.

We added to our position in China Overseas Land & Investment (COLI). The share price had been weakened by the risk of US investors selling down on new government restrictions, yet there is no change to the underlying business, and we continue to like COLI's strong balance sheet and attractive relative valuation. We also divested from Coal India; this not only reduces our risk, but importantly reduces the carbon exposure of our portfolio.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
