
## FUND CHARACTERISTICS

The fund provides exposure to a range of different asset classes that may include equities, bonds, property, commodities, and listed infrastructure, private equity and global real estate companies, which may be actively or passively managed. The asset allocation of the fund is managed by LGIM with the aim of enhancing returns and managing downside risk. The fund provides exposure to a combination of UK and overseas assets with a flexible approach to managing foreign currency exposure.

Derivatives may be used for efficient portfolio management.

### FUND MANAGER COMMENTARY

Investor confidence returned in the first quarter of 2019, with asset prices rising across the board. Higher-risk assets were particularly strong in January and February and were joined by government bonds and credit in March. Both developed and emerging market equities performed strongly, with North American and Chinese indices leading the pack. Listed real estate and infrastructure also performed well. The US Federal Reserve signalled that rate rises are off the table, while the European Central Bank pushed out rate rises until at least next year.

The fund generated a positive return. The main contributions to performance came from US equities and global infrastructure. Currency hedging into sterling added to returns, especially given our increased exposure to the pound. Exposure to euro corporate bonds detracted marginally from performance.

We were tactically long equities going into January and reduced this in mid-February on valuation grounds. In order to take advantage of reflation in China, we took positive exposure to the European basic resources sector against a short UK equities position and long Chinese equities against an emerging markets short position. We increased credit risk in early January by switching the fund's US credit exposure into the LGIM Future World USD Corporate Bond Index. We retain large exposure to US inflation assets to help protect against the risk that higher inflation causes the US Federal Reserve to need to raise interest rates further. From late January, we started increasing European duration risk.

### FUND MANAGERS

The Fund is managed by LGIM's Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM's client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
