FUND AIM

The objective of the Fund is to provide growth above that of the FTSE World Europe ex UK TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 4% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

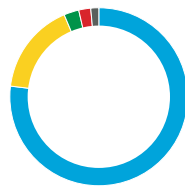

FUND MANAGER COMMENTARY

It was a month of gains for most major equity markets as risk levels returned to normalised levels. Risk appetite appears healthy, with confidence in growth from the global economy and corporate profits close to historic peaks. Some spectators have recently argued for a market correction on the basis of technicals & valuations looking stretched, peaking PMI momentum, complacency in respect of vaccines and traditional 'sell in May' rhetoric. Bullish equity momentum may begin to see fatigue, however, given the growth-policy trade off is likely to remain supportive, we would not expect any market pullback to be sustained ahead of a period of economic recovery in the coming quarters.

Turning to equity performance, the interesting ebb and flow of style returns varied throughout the month. While it is clear cyclicals have grown in popularity at the expense of momentum and defensive factors, companies with prospects of sustainable growth continue to find favour. Q1 earnings season has been positive for market fundamentals and performance of holdings in the fund so far, as beat rates continue to come in ahead of historical averages.

The L&G European Trust delivered a positive return of 4.3%, which broadly matched the benchmark return. Stock selection added alpha, driven by gains within Industrials and Consumer Discretionary industries. Sector allocation detracted value due to the underweight to Consumer Staples. Top individual stock performers included Fluidra, Delivery Hero, InPost, Umicore and Nestle. The largest detractors were Soltec Power, Infineon and Shop Apotheke. For trading activity, there was no notable activity in the period.

CARBON RESERVES
