FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.



- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.



FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned +2.8% in January in GBP terms, whilst the fund returned +0.3%.

By country, China was the strongest region in the index. This detracted from performance given our underweight allocation to the country based on the weak corporate governance we find there. Australia, where we have an overweight allocation, underperformed the overall index, also negatively contributing to relative returns. Our underweight position in India was a positive.

In terms of sectors, Technology enjoyed a strong month. Our underweight position in the sector was offset by strong stock selection. Telecommunications and Industrials, both sectors where we hold large overweight positions, lagged the broader index, negatively contributing to returns.

At a stock level, once again Lenovo was our strongest contributor to fund performance, with the company continuing to benefit from the working from home trend. The company has regularly been a top performer since adding the position to the portfolio last year. TSMC also performed strongly. The largest negative contribution to relative returns came from not owning Tencent.

In terms of activity, we entered a new position in Beijing Enterprises Water, a water utility company, reducing our China underweight position. We believe there are opportunities for improved returns as standards tighten. The company is also involved in large scale environmental remediation contracts to clean rivers and lakes. Both areas should continue to be in focus in the government's 14th 5-year plan. We sold our position in China Shenhua Energy, further reducing our coal exposure and aligning the portfolio with LGIM's coal policy.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS
