FUND AIM

The investment objective of the fund is to provide long-term investment growth through dynamic exposure to a diversified range of asset classes. The long-term expected annualised rate of return for this fund is the Bank of England Base Rate +4.5% per annum, over a full market cycle.


WHO IS THIS FUND FOR?


FUND CHARACTERISTICS

The fund provides exposure to a range of different asset classes including equities, bonds, property, commodities and listed infrastructure, private equity and global real estate companies, which may be actively or passively managed. The asset allocation of the fund is managed by LGIM with the aim of enhancing returns and managing downside risk. The fund provides exposure to a combination of UK and overseas assets with a flexible approach taken to managing foreign currency exposure.

Derivatives may be used for efficient portfolio management.

FUND MANAGER COMMENTARY

The LGIM Dynamic Diversified Fund returned +1.1% over the quarter. This brings the total return since inception to +7.6% per annum versus an objective of +5.0% per annum.

The main asset contributions to performance came from currency hedging into the pound, and from North American and emerging-market equities. In terms of detractors, emerging-market debt, US inflation-linked bonds, and listed real estate weighed on performance. This was predominantly due to the strength of the pound as we take the returns on these asset classes in unhedged terms.

We tactically reduced equities during the quarter, reflecting the stronger performance of equities against the backdrop of an overall environment that still retains a number of risks. We switched half of the Fund's emerging-market equity exposure to the Future World Emerging Market Equity Index funds (these funds tilt relative to a market-capitalisation approach based on LGIM's ESG score) to help improve the ESG quality of the portfolio and mitigate some climate risks. We added a position in German bunds as yields are up significantly from their lows and now offer attractive carry relative to the European Central Bank's negative deposit rate.

As a risk-management position, we bought calls on the pound prior to the UK general election. We took profits on the position in the Mexican peso. We added a position in the Chilean peso following weakness as the central bank has begun to support the currency.

FUND MANAGERS

The Fund is managed by LGIM's Asset Allocation team. The team has a wealth of experience in fund management, investment strategy and economics. They are responsible for a wide range of multi-asset funds and investment strategies across LGIM's client base. The Fund allows a broad range of pension fund investors to access this expertise.

The day-to-day implementation of the allocation of the fund is managed by the Allocation Strategy Management team.
