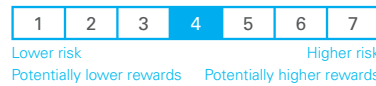

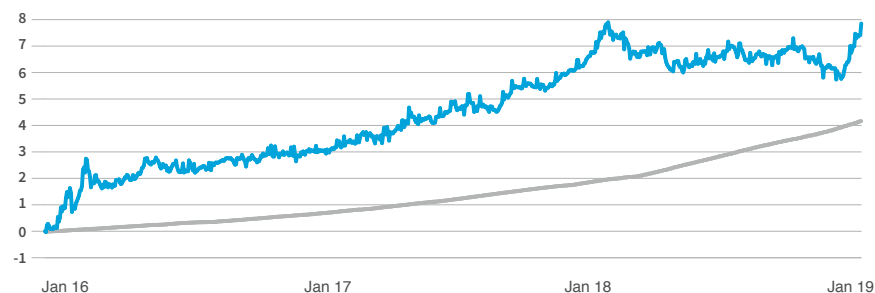

FUND MANAGER COMMENTARY

January witnessed a strong rebound across just about every asset class, reversing December's weakness. The combination of attractive valuations and a dovish shift from the US Federal Reserve provided the impetus for a very strong start to the year. The overall impact was for a weaker dollar and range-bound treasury yields. This combination proved particularly bullish for emerging markets.

The fund delivered positive returns in January, with our holdings in US investment grade credit proving beneficial for performance. In particular, our exposure to Energy Transfer Partners, Store Capital and Georgetown University contributed positively. Our long duration bias and overweight in European versus US duration risk was also beneficial. However, our protective hedges, including thematic single name short positions in selective auto and commodity companies proved negative for performance amid the market rally.

Looking ahead, the dovish shift from Jerome Powell is clearly very important given the concerns we have about tightening liquidity conditions, particularly in the US. Therefore, tactically holding more credit risk makes sense to us at this juncture. However, we retain our cautious longer-term outlook for credit markets and would look to sell into further strength.

Julien is a portfolio manager in the Multi-Strategy Fixed Income team where he is responsible for global credit and absolute return mandates. He joined LGIM in September 2007 from Fortis Investments, where he was a quantitative strategist in the structured finance team and developed market standard and proprietary models for the pricing and risk management of credit derivatives as well as trading and hedging strategies. Julien has a PhD in financial modelling from the Ecole Normale Supérieure, Paris, France.

KEY RISKS
