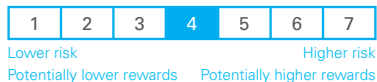

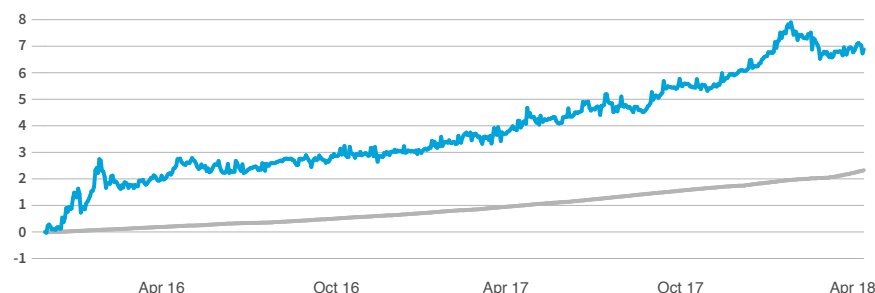

FUND MANAGER COMMENTARY

April was a more stable month for risky assets following a weak March. Within investment grade credit, US dollar and euro spreads were roughly flat overall despite signs that the European Central Bank had reduced their corporate bond purchases. Sterling credit outperformed, while high yield credit was also tighter during the month.

The fund delivered positive returns in April with holdings in investment grade bonds contributing to performance. However, our short CDS position in investment grade credit detracted from performance. We continued to hold short positions in bunds (on the back of rising inflation expectations) and Italian government bonds (given the rise in anti-establishment parties following the Italian elections). Currency positions were beneficial for performance over the month, and we continued to hold a long position in the US dollar versus a range of currencies. Our equity tail hedges detracted from performance, but we continued to hold longer-dated equity put spreads as tail risk hedges.

Looking ahead, with US government bond yields rising alongside the US dollar, markets are undergoing another bout of global liquidity tightening. Central banks may reduce their hawkish policy to an extent, but the direction of travel remains for tightening. We have already seen some weakness across emerging markets and it would not be surprising to see that spread further.

Julien is a portfolio manager in the Multi-Strategy Fixed Income team where he is responsible for global credit and absolute return mandates. He joined LGIM in September 2007 from Fortis Investments, where he was a quantitative strategist in the structured finance team and developed market standard and proprietary models for the pricing and risk management of credit derivatives as well as trading and hedging strategies. Julien has a PhD in financial modelling from the Ecole Normale Supérieure, Paris, France.

KEY RISKS
