FUND AIM

The objective of this fund is to provide growth by investing predominantly in shares of UK companies. The fund will seek to achieve its objective by investing at least 80% in shares of UK companies with an aim to outperform the FTSE All Share Index (the "Index") by 3% per annum before charges, over a rolling three year basis.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 5 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.



FUND MANAGER COMMENTARY

Following a strong first quarter for risk assets, equity markets extended their recent strength in April. Seemingly, investor assumptions imply many of the global economic events will be resolved favourably, but it's likely the onus falls on corporate earnings to have a determining impact on price momentum going forwards. Expectations are low, but the early signs from the reporting season are that results are broadly exceeding expectations.

In the UK, the extension of the Brexit deadline was largely anticipated, though is hardly welcome news for investors. From a data perspective, there is some distortion from stock building that has impacted trade and exports readings. However, this should begin to unwind in Q2. On a more positive note, the consumer continues to hold-up well. Confidence measures, labour data and retail spend all appear resilient.

Turning to market performance, global sector leadership was mainly with industrials, financials, consumer services and tech. This reflected ebbing concerns about the global economic outlook. In the UK, mid-caps were also very strong performers, helped by domestic cyclical plays. On the flipside, we saw disappointing returns for some defensive mega-caps.

The L&G UK Select Equity fund delivered very strong performance in April, closing the month with a net gain of 6.8%. The portfolio benefitted from its favourable overweight to cyclicals. Stock selection in consumer services, industrials and mid-caps made a leading contribution. There was the added benefit from our underweight in the healthcare sector.

Gavin joined LGIM in 2007 and has been the Fund Manager for the UK Select Equity Fund since June 2018. Previously, he was a Global Equities Analyst at BlueBay Asset Management. Gavin spent the majority of his buy-side career as a Portfolio Manager with UBS O'Connor. Prior to this, he was a top-rated, sell-side analyst covering the Autos, Capital Goods and Conglomerates sectors at investment banks including SG Warburg (now part of UBS) and Goldman Sachs. Gavin holds a degree in Philosophy and Economics from University College, London.
