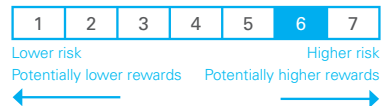

FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

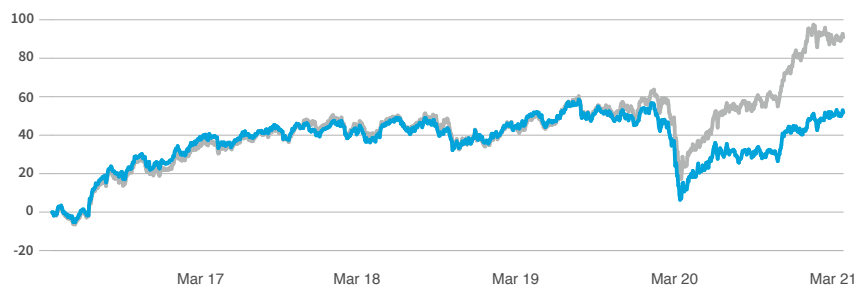

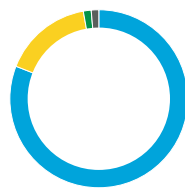



FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned -0.6% in March in GBP terms. The fund outperformed the index with a return of +1.9%. Concerns on rising inflation and bond yields persisted from the prior month. This, along with gathering momentum in the reopening trade, contributed to value outperforming growth in global equity markets, including Asia. The fund's performance continues to benefit from such a factor rotation given the manager's value and income bias.

By country, China significantly lagged the broader index due to investor concerns around moderate policy tightening. This made a positive contribution to relative performance given our underweight allocation to this region based on the weak corporate governance we find there. Our overweight allocation to Australia and Singapore also made a positive contribution, with both regions outperforming the overall index.

Sector allocation was also positive, with fund performance benefiting from our underweight positions in Health Care and Consumer Goods given the weak performance of these sectors during the month. Cyclical sectors performed strongest during the period. Our overweight positions in Financials and Oil & Gas were therefore also beneficial. This was partly offset by our underweight position in Basic Materials.

At a stock level, the strongest contributors to relative fund performance came from KB Financial and Lenovo. Not owning Alibaba and Tencent was also beneficial. The largest negative contributions to relative returns came from our holdings in Yuzhou and CNOOC.

There were no notable portfolio changes in the period.

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS
