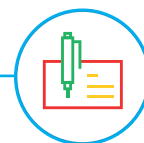


L&G Absolute Return Bond Plus Fund

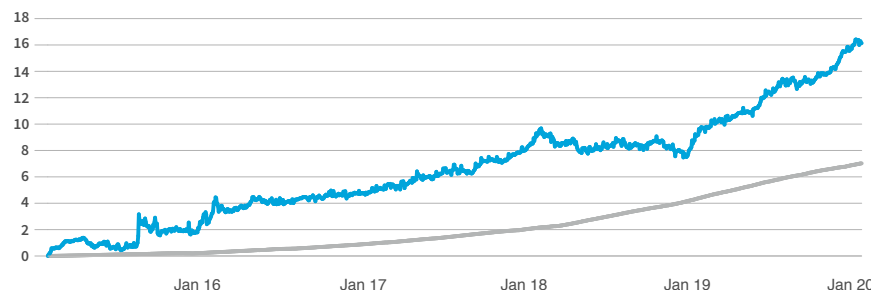
