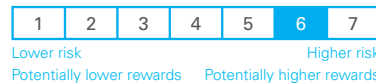

FUND AIM

The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 4% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

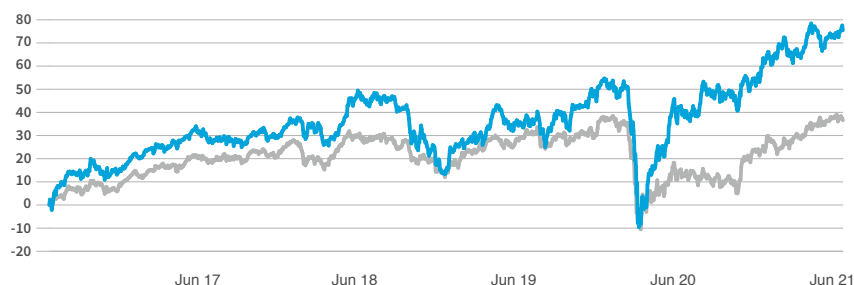

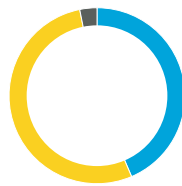

FUND MANAGER COMMENTARY

Equity markets continued their positive year-to-date trajectory with most regions closing June at or close to record highs. The pullback in long-term government bond yields and decline in market-derived inflation expectations has been helpful in removing potential equity valuation headwinds. While it is speculated that we are now close to the peak in activity indicators and the Fed moving closer to tapering, we believe that the market is likely comfortable with the notion that growth will remain above trend in the second half of the year. In the UK, the key messages from the Bank of England remained dovish, while latest retail and housebuilder data proved robust.

In a month of favourable performance for the fund, we saw investors rotate back towards growth stocks as long-term rates fell, while doubts over the relaxation of Covid-19 restrictions have hurt the reopening plays. At the sector level, Healthcare, Technology and Energy stocks outperformed. Basic Materials, Financials and Consumer Discretionary industries were the laggards.

The L&G Growth Trust delivered a positive return during the month and outperformed its benchmark by 120bps. Stock selection and sector allocation both made a positive contribution. The overweight to Technology and underweight in Financials and Miners added most value. Selection in Software and Financial Services sub-industries were the largest positives. By stocks, the key outperformers were Darktrace, Alphawave, Aveva and Ocado Group. Detractors included GB Group, RWIS Holdings and Network International. We introduced new positions in Technology companies Alphawave and GB Group. Holdings of Wizz Air and HomeServe were both sold.

Gavin joined LGIM in 2007 and has been the Fund Manager for the UK Growth Trust since September 2014. Previously, he was a Global Equities Analyst at BlueBay Asset Management. Gavin spent the majority of his buy-side career as a Portfolio Manager with UBS O'Connor. Prior to this, he was a top-rated, sell-side analyst covering the Autos, Capital Goods and Conglomerates sectors at investment banks including SG Warburg (now part of UBS) and Goldman Sachs. Gavin holds a degree in Philosophy and Economics from University College, London.



ENVIRONMENTAL PERFORMANCE

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
