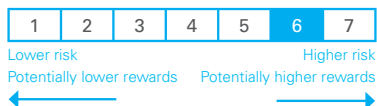

## FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

## RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

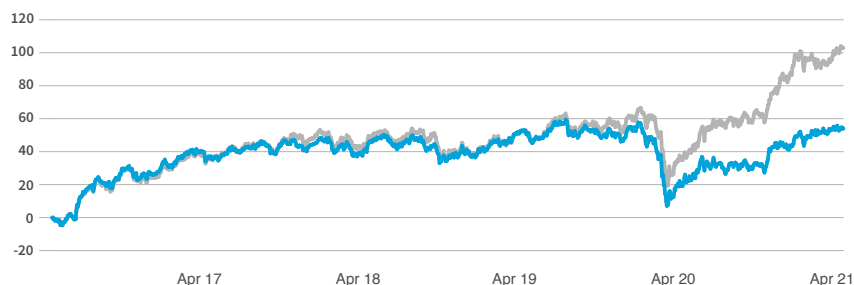

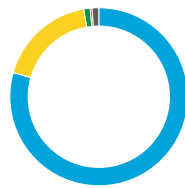
- **What does it invest in?** Invests at least 80% in shares in companies throughout Asia, including Australasia, but excluding Japan.

## FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned 2.6% in April in GBP terms whilst the fund returned +0.8%.

By country, India was one of the weakest performing regions, with particular concerns on the scale of the recent outbreak in COVID-19 infections. China also lagged the broader index with investor concerns remaining around moderate policy tightening and tougher regulations on the technology sector. This made a positive contribution to relative performance given our underweight allocation to these regions based on the weak corporate governance we find there. Our overweight allocation to Australia and New Zealand also made a positive contribution, with both regions outperforming the overall index.

Sector allocation was negative, driven by our underweight positions in Health Care and Basic Materials, with both of these sectors outperforming in the month. This was partially offset by the fund benefitting from its overweight allocation to Industrials, with this sector also having a strong month.

At a stock level, the strongest contributors to relative fund performance came from our holdings Transurban, Taiwan Cement and Downer EDI. The largest negative contributions came from our holdings in MGM China, due to slower than expected recovery in both VIP and mass market gross gaming revenue, and China Construction Bank, where profitability missed estimates due to a slight contraction in net interest margin. Lenovo also experienced weakness following longer-term strong performance.

There were no notable portfolio changes in the period.



### PAUL HILLSLEY

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

## ENVIRONMENTAL PERFORMANCE

Carbon dioxide (CO<sub>2</sub>) is the most significant contributor to greenhouse gas emissions which are driving climate change.

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

### CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>ii</sup>.


