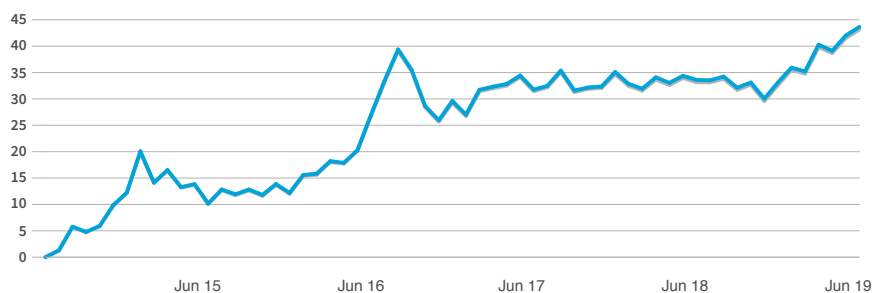
## WHO IS THIS FUND FOR?

## FUND CHARACTERISTICS

The fund invests in LGIM's index-tracking bond funds to gain exposure to these assets. The fund, however, cannot provide full protection against changes in annuity rates for individual members since these also depend upon a number of other factors (e.g. changes to mortality assumptions). The asset allocation is reviewed quarterly by the Portfolio Solutions team and the fund will not take short-term, tactical asset allocation positions.

### Benchmark note

The benchmark asset allocation for the Fund is a composite of gilts and corporate bond funds.

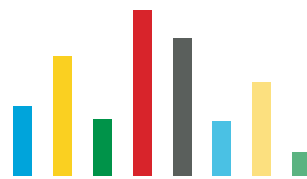

### FUND MANAGERS

The Fund's strategic asset allocation is set and maintained by LGIM's Portfolio Solutions team. This team has a wealth of experience and is drawn from financial, actuarial and consultancy backgrounds. They are involved in asset allocation work for a wide range of LGIM's clients, typically large pension and insurance funds.

The allocation is managed by the Allocation Strategy Management team. Management oversight is provided by the Director, Allocation Strategy Management. The team of 10 has an average industry experience of 13 years, of which six years has been at LGIM.

## KEY RISKS

However, in the event of the failure of a counterparty, custodian or issuer there is a residual risk that a fund may suffer asset losses which are unrecoverable.
