- **How does it invest?** Actively managed, with holdings in 25 companies on average over a typical market cycle of 3-5 years, which means the fund will be concentrated.



FUND MANAGER COMMENTARY

December confirmed the strong performance of global equities in 2019. The biggest market event was seen in the UK, where the general election outcome was favourable for domestic-focused equities, as Boris Johnson's Conservative party won by a clear majority. Elsewhere, markets also benefited from the reaction to the latest announcement of a phase 1 agreement between the US-China, as tensions moderated over the trade deal. Meanwhile, economic data continues to hold out. Finally, the Bank of England and Fed opted to keep central bank policy rates on hold. The Fed signalled they would likely remain so through 2020.

In respect of equity market performance, style factors continue to deviate regionally, though the Q4 rebound for Cyclical and Financials in the UK continued. Miners also enjoyed a better month. By size, Large-caps were weak on a relative basis, given mid and small-cap gearing to Brexit positivity. Value once more advanced, though Quality also fared well.

For the fund, the L&G Growth Trust recorded a positive return of 2.2%. Yet this underperformed a strong benchmark performance. Sector and size allocation was unhelpful, given the underweight in Utilities and Resources, alongside the relative hit from strength in domestic-focused UK mid and small-caps. Stock selection was more mixed. Helios Towers, Network International, Just Eat and JD Sports all performed well. Not owning market-cap heavyweights British American Tobacco, Rio Tinto and HSBC was a key part of relative underperformance. Elsewhere, RWS Holdings detracted value.

Gavin spent the majority of his buy-side career as a Portfolio Manager with UBS O'Connor. Prior to this, he was a top-rated, sell-side analyst covering the Autos, Capital Goods and Conglomerates sectors at investment banks including SG Warburg (now part of UBS) and Goldman Sachs. Gavin holds a degree in Philosophy and Economics from University College, London.
