FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE World Europe ex-UK TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

The fund is in category 6 because it invests in company shares which are sensitive to variations in the stock market. The value of company shares can change substantially over short periods of time.

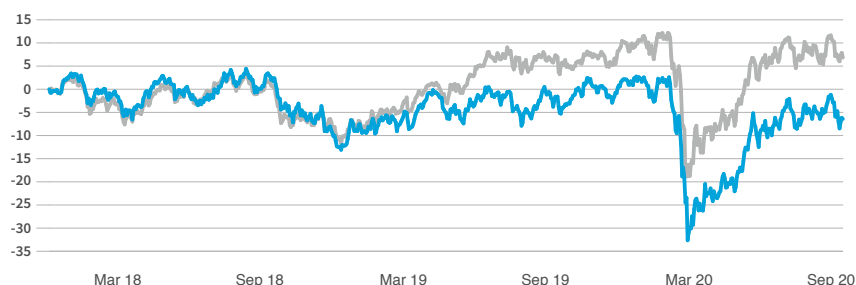

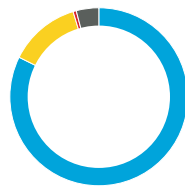

FUND MANAGER COMMENTARY

Following a tricky September, where a surge in country-level coronavirus cases led risk assets lower, it seems prudent to observe a period of market caution. We now enter the fourth quarter with growing uncertainty as increasingly well-known tail risks (Covid resurgence, US elections, Brexit) threaten to derail the uneven European economic recovery. Recent market developments suggest a more rational pricing of risks, though we are cautious on prospects into the next corporate reporting season.

In respect of European equity markets, it was another month of Value underperforming Growth and Quality style tilts. At the sector level, market leadership came from consumer services, healthcare and consumer goods. On the flipside, oil & gas, financials and telecom industries all reported negative returns in the period.

The L&G European Equity Income fund delivered an absolute return of -1.3%, which reflected 200bps underperformance of its benchmark. Sector allocation and stock selection both made small negative contributions to relative performance. Selection within financials and both resource sectors detracted most value, though this was partially offset by robust gains within industrials and healthcare. Turning to sector allocation, the overweight in financials and oil & gas continues to be unhelpful. As too does the underweight to consumer goods, which outperformed. At the stock level, the largest detractors to returns were BNP Paribas, ENI, Societe Generale, Norsk Hydro, ING Group and AXA. From a more positive perspective, contributions from Merck, Novo Nordisk and ArcelorMittal added value.

There was no significant new activity in the period.

CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.
