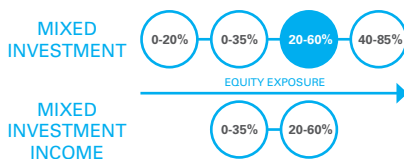

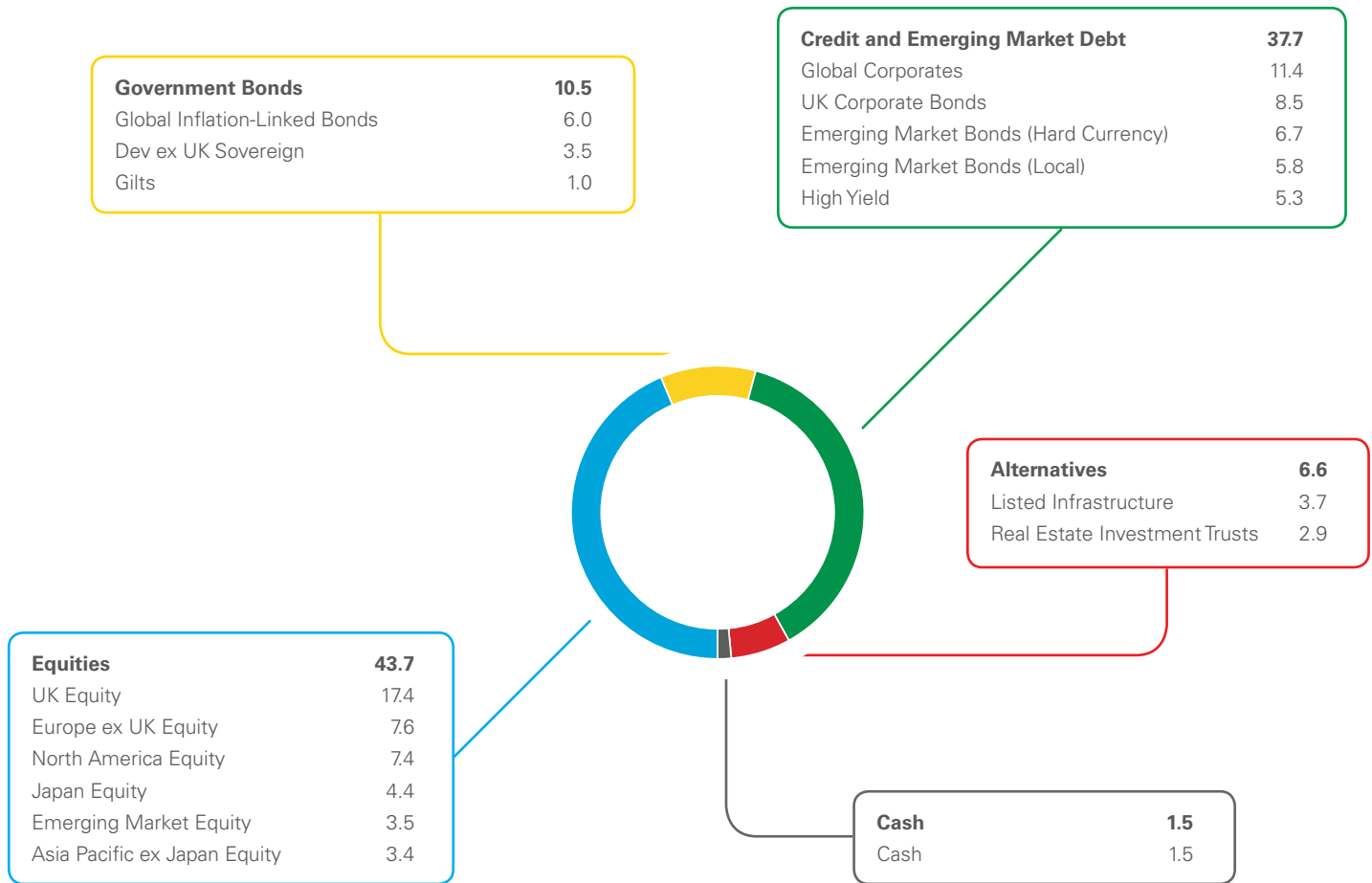
FUND SNAPSHOT

RISK AND REWARD PROFILE

KEY RISKS
