The objective of this fund is to provide income, with some potential for growth. The fund will invest in a broad spread of company shares from all economic sectors. The company shares the fund invests in will be from Asia (excluding Japan), the rest of the Pacific region and Australasia.

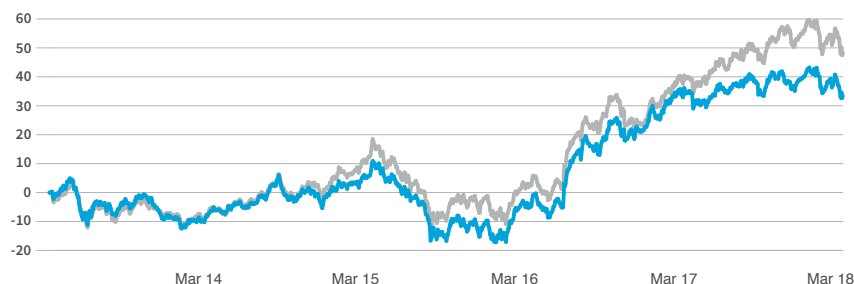

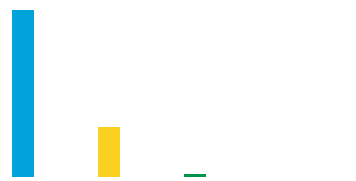

FUND MANAGER COMMENTARY

It was a tough month for risk assets as volatility returned. Geopolitical turmoil coincided with fears of a slowdown in global growth, which was further compounded by worries about rising inflation and faster interest rate hikes. The subsequent fallout saw sharp share price falls around the world, with tech stocks and cyclicals hit hardest of all.

Asia Pacific ex Japan equities continued to decline in March, falling 4%. China underperformed, led by sell-offs in the internet heavyweights Baidu, Alibaba and Tencent. Australia also underperformed in the month, as the banks suffered from the regulator seeking to raise capital requirements and mining companies fell on tumbling resources prices. Korea was relatively strong as Samsung bounced on the release of the founding family's heir from jail after the suspension of his corruption related sentence and the won strengthened on improved prospects of North Korean denuclearisation.

The Asian Income fund delivered a negative performance during March, although this was in line with the index. At a country level, our overweight in Australia was a drag, however this was offset by positive relative returns from our positioning in China and India where we are underweight. Stock selection in industrials and financials was detrimental though was offset by gains in the resource sectors. Sector allocation was broadly neutral in the period and we benefitted from our underweight in tech, though this was offset by our overweight in telecoms.

Paul joined LGIM in 2006 and is lead Fund Manager for the Asian Income portfolios. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Legal & General Asian Income Trust and in 2013 formed the Global Income Team, which forms the core of the firm's equity income expertise. He read Engineering, Economics and Management at Lincoln College, Oxford University and is an Associate of the Society of Investment Professionals.
