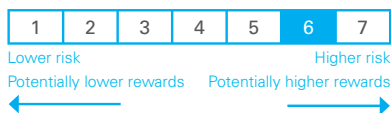

FUND AIM

The investment objective of the fund is to track the performance of the RAFI Multi-Factor Developed Index- GBP Hedged (less withholding tax where applicable) to within +/-0.75% p.a. for two years out of three. There are no separate income, performance or volatility targets.

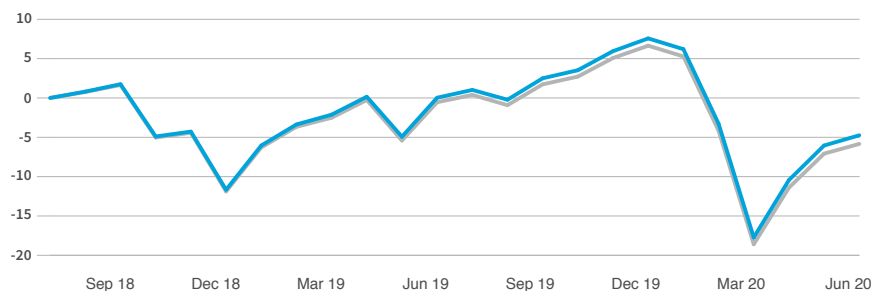
WHO IS THIS FUND FOR?

FUND CHARACTERISTICS

The fund employs an index tracking strategy, aiming to replicate the performance of its benchmark. This index is not market capitalisation weighted and offers diversified factor exposures through allocations to value, low volatility, quality, momentum, and size (equally weighting a blend of these five factors). We follow a pragmatic approach to managing index funds, either investing directly in the securities of that index, or indirectly through other LGIM funds. The fund may also hold index and single stock futures for efficient portfolio management. Currency hedging is achieved by selling forward for approximately one month the relevant currency exposure of the fund.

INDEX FUND MANAGEMENT TEAM

The Index Fund Management team comprises 25 fund managers, supported by two analysts. Management oversight is provided by the Global Head of Index Funds. The team has average industry experience of 15 years, of which seven years has been at LGIM, and is focused on achieving the equally important objectives of close tracking and maximising returns.

KEY RISKS
