## FUND AIM

The objective of the Fund is to provide income and growth above those of the FTSE Asia Pacific ex-Japan TR Net Index (the "Benchmark Index"). The Fund aims to outperform the Benchmark Index by 2% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.

## RISK AND REWARD PROFILE



The synthetic risk and reward indicator (SRRI) is based on the historic volatility of the fund's value and it may change in the future.

- **How does it invest?** Actively managed, with holdings in between 40 and 80 companies on average over a typical market cycle of 3-5 years.

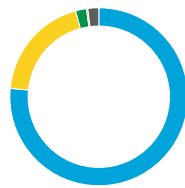

## FUND MANAGER COMMENTARY

Asia Pacific ex Japan equities returned +2.3% in October in GBP terms. The fund returned -1.8% over the month. In Asia, unlike other geographical regions, growth style continued to outperform value which hampered the fund's performance given the manager's value and income bias.

By sector, technology led the market higher whilst Oil & Gas was the worst performing. Our underweight to technology, due predominantly to not owning the zero or extremely low yielding stocks Alibaba, Meituan and Tencent therefore negatively contributed.

By country, China, led by the large cap technology stocks, outperformed the broader index which meant our underweight position there hurt asset allocation. Australia, where we are overweight due to the significantly better disclosure and corporate governance versus large parts of the rest of the region, underperformed the market in the month. On a stock selection basis, Australian holdings such as Transurban and Telstra were also disappointingly weak.

KB Financial Group, a leading Korean bank we own, reported strong Q3 results in the month which led to it being one of the biggest positive contributors to performance. Asset quality remains robust and their acquisition of Prudential's Asian life insurance business will make a significant contribution to earnings going forward. We continue to have conviction in this well-capitalised bank.

October was not an active month in terms of portfolio trading.



### PAUL HILLSLEY

Paul joined LGIM in 2006 and is the lead fund manager for the Asian income portfolios. He has managed the Asian Income Trust since its inception. He began his investment career in 1991 at Phillips and Drew Fund Management, now called UBS Global Asset Management, and developed broad experience across UK, Europe, Japan and, predominantly, Asia ex Japan, over subsequent years. At LGIM Paul launched the Asian Income Trust in November 2008 and in 2013 formed the Global Income Team which, together with Andrew Koch, Stephen Message and Camilla Ayling forms the core of the firm's equity income expertise. He read engineering, economics and management at Lincoln College, Oxford University, and is an associate of the Society of Investment Professionals.

## ENVIRONMENTAL PERFORMANCE

Carbon dioxide (CO<sub>2</sub>) is the most significant contributor to greenhouse gas emissions which are driving climate change.

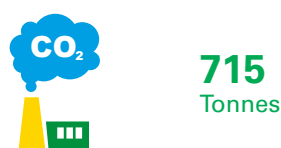


CO<sub>2</sub>e<sup>i</sup> per \$1 million of market capitalisation

### CARBON RESERVES

Carbon reserves are fossil fuels (coal, oil and gas) which, if burnt, will become the carbon emissions of the future. To meet global climate change targets, the unabated use of fossil fuels is expected to decline over time.

The figure is a measure of the size of carbon reserves held by the fund's underlying companies.

### CARBON EMISSIONS

Following the global Paris Agreement on climate change, companies in all sectors are expected to reduce their emissions to prepare and adapt for a low-carbon economy.

Carbon emissions intensity describes the relationship between the carbon emissions of a company and its sales<sup>ii</sup>.
